ORDER:

In Government Order first read above, orders were issued for transferring the administrative control of certain Peripheral Hospitals/ Dispensaries from Director of Medical and Rural Health Services to Director of Medical Education. Subsequently, in Government Order second read above, orders were issued, attaching certain Government Peripheral Hospitals/Dispensaries with Government Medical College and Hospitals.

2. The Director of Medical Education has justified that if the Government Peripheral Hospitals are upgraded as Centre of Excellence for each speciality, it will improve the quality of Health care and facilitate, the poor patients to undergo treatment in the nearby Government Peripheral Hospitals. Further the above Government Peripheral Hospitals are attached with the major Government Medical College/ Hospitals in Chennai city, which will reduce the work load in the Hospitals and will facilitate the Medical officers working in the Government Peripheral Hospitals to undergo teaching as a part of curriculum.

3. In the Government Order third read above, among others the Government has issued orders as follows:-

“the Medical Officers in Peripheral Hospitals are not doing teaching work. Therefore they may be declared as Non-Teaching posts such as Assistant Surgeon/ Civil Surgeon / Senior Civil Surgeon. In their place the senior most Diploma holders and MBBS qualified Medical Officers working in the Director of Medical Education may be accommodated”.

4. The Director of Medical Education has therefore requested the Government to convert certain Government Peripheral Hospitals under the control of the Director of Medical Education as “Centre of Excellence” and redesignate the existing posts of Assistant Surgeon/Senior Civil surgeon/ Civil surgeon available in these Government Peripheral Hospitals as teaching posts as Associate professor/ Assistant Professor/Senior Residents for various specialities according to the qualification and need.

5. The Government have examined the proposal of the Director of Medical Education in detail and decided to accept it. Accordingly, the Government passes the following orders:-

i) the following Peripheral Hospitals be converted as ‘Speciality Units’ in the Speciality mentioned against them as detailed below:-

S. No	Name of the Peripheral Hospital	Name of the Speciality Unit
1	Government Peripheral Hospital, Anna Nagar, Chennai.	Speciality Unit in Medical Gastroenterology.
2	Government Peripheral Hospital, K.K.Nagar, Chennai.	Speciality Unit in Orthopaedics.
3	Government Peripheral Hospital, Tondiarpet, Chennai.	Speciality Unit in Non communicable Diseases.
4	Government Peripheral Hospital, Periyar Nagar, Chennai.	Speciality Unit in Infectious Diseases.
5	Government Peripheral Hospital, Enjambakkam, Chennai.	Speciality Unit in Trauma care.
6	Government Peripheral Hospital, Thiruvottiyur, Chennai.	Speciality Unit in Occupational Diseases.

ii) the Director of Medical Education be permitted to redesignate the existing posts of Assistant Surgeon/ Civil Surgeon/Senior Civil Surgeon in the above six Government Peripheral Hospitals as teaching posts as Senior Resident/ Assistant Professor/ Associate Professor for various specialities as indicated above according to the qualification and need, to satisfy MCI (Medical Council of India)

norms and also to enable them to gain teaching experience, without any financial commitment to the Government.
