ORDER:

In the G.O. 1st read above orders have been issued framing Service Rules for the various posts. In G.O. 2nd read above, orders have been issued ratifying the action of the Managing Director, Tamil Nadu Medical Service Corporation Limited in having created 379 posts in 26 categories (including Dark Room Assistants in the scale of pay Rs.4000-100-6000), without proper approval of the Government, in relaxation of G.O.(Ms) No.27, Finance (BPE) Department, dated 21.01.2002.

- 2. The Managing Director, Tamil Nadu Medical Service Corporation Limited has now stated that the Dark Room Assistants have represented to change the designation of Dark Room Assistant as Radiographer and also to enhance the time scale of pay or par with the candidates recruited by the Government Hospitals and also to regularize their services as is being done in the Government Hospitals.
- 3. Since the Education / Technical Qualification for the post of Dark Room Assistant in Tamil Nadu Medical Service Corporation Limited and that of Radiographer in Government Hospital are one and the same, the Tamil Nadu Medical Service Corporation Limited in the 107th Board Meeting held on 13.06.2013, among others resolved the following:-
 - (a) to upgrade the post of Dark Room Assistant as Radiographer as person specific up-gradation on completion of 5 (Five) years of service of the Dark Room Assistants from the date from which their services have been regularized.

- (b) to fix their pay in the Pay Band 3 of Rs.9300-34800 + Grade Pay Rs. 4200/as per G.O.(Ms).No.296 Finance (Pay Cell) Department, dated 26.08.2010 and Government Letter No: 51082 / Pay Cell / 2010-1, Finance (PC) Department, dated 15.09.2010.
- (c) to fix the pay with notional effect from 01.01.2006 and Monetary benefit with effect from 01.07.2013.
- (d) to issue necessary amendment to the Service Rules with reference to Dark Room Assistant.
- 4. The Managing Director, Tamil Nadu Medical Service Corporation Limited has the refore requested the Government to accept the above and issue necessary orders in this regard.
- 5. The Government after careful examination on the request of the Managing Director, Tamil Nadu Medical Service Corporation Limited have decided to accept the same with certain modifications. Accordingly, the Government issue the following orders:
 - a) the posts of Dark Room Assistant in the Tamil Nadu Medical Service Corporation Limited shall be upgraded as Radiographer as and when the Dark Room Assistants complete 5 years of service with effect from 01.01.2006, in relaxation of G.O.(Ms) No.27, Finance (BPE) Department dated.21.01.2002, subject to the condition that the resultant post of Dark Room Assistant shall stand abolished and the Corporation should maintain the cadre strength (Dark Room Assistant and Radiographer both put together) not exceeding 159 posts. The category of Dark Room Assistant will cease to exist on upgradation of all the Dark Room Assistants as Radiographers.
 - b) their pay shall notionally be fixed with effect from 01.01.2006 and as per the subsequent revision orders issued for the post of Radiographers in Government with monetary benefit with effect from 01.07.2013.
- 6. Orders with regard to amendment of the Service Rules for the post of Dark Room Assistant will be issued separately.
- 7. This orders issues with the concurrence of Finance Department vide its U.O.No. 32776/Finance (BPE) Department, dated 18.06.2014.
