ORDER:

The Mission Director, State Health Society in his letter second read above has stated that the Central funds under the Centrally sponsored Schemes like National Health Mission are routed through the Treasury route as part of the State plan and requested to provide for Central Share of National Health Mission in the State Budget. The Government of India in their three separate orders first read above have transferred and credited a sum of Rs.1,44,98,00,000/- (Rupees One hundred and forty four crore and ninety eight lakh only) into State Government account as their 75% share of Grants in Aid for the financial year 2015-16 for the implementation of the schemes RCH Flexible pool including Pulse Polio Immunisation Programme and NIDDCP for the year 2014-15 as mentioned below:-

The Government of India have requested to ensure 25% State contribution based on the release of funds by Government of India

2. The Mission Director, State Health Society has further stated that the corresponding 25% of the State Share against the 75% of the Government of India release of Rs.1,44,98,00,000/- (Rupees One hundred and forty four crore and ninety eight lakh only) works out to a sum of Rs.48,32,66,666- (Rupees Fourity eight crores thirty two lakh sixty six thousand six hundred and sixty six only). Since Government of India have transferred the grants to State Government for drawal of amount through Treasury route from 2014-15, the amount of Central Share and State Share will have to be drawn from State Budget. He has requested the Government to issue orders to

release a sum of Rs.1,93,30,66,666/- (Rupees One hundred and Ninety three crore thirty lakh sixty six thousand six hundred and sixty six only) towards release of Central and State contribution of Grants in aid to the State Health Society under Reproductive Child Health Flexible Pool including Pulse Polio Immunisation Programme and NIDDCP for the year 2015-16 and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu to draw a sum of Rs.1,93,30,66,666/- (Rupees One hundred and Ninety three crore thirty lakh sixty six thousand six hundred and sixty six only) under National Health Mission through Treasury mode.

3. The Government after careful consideration have decided to accept the above proposals of the Mission Director, State Health Society and accordingly sanction a sum of Rs.1,93,30,66,666/- (Rupees One hundred and Ninety three crore thirty lakh sixty six thousand six hundred and sixty six only) i.e., Rs.1,44,98,00,000/- (Rupees One hundred and forty four crore and ninety eight lakh only) being 75% of central share and Rs.48,32,66,666- (Rupees Fourty eight crore thirty two lakh sixty six thousand six hundred and sixty six only) being 25% of the State share as matching grant to the State Health Society, Tamil Nadu to implement the Reproductive Child Health (RCH) Flexible Pool including Pulse Polio Immunisation Programme and NIDDCP during the year 2015-16.
