## ORDER:-

In the letters read above, the Director of Medical Education has stated that the Dean, Madras Medical College/ Rajiv Gandhi Government General Hospital, Chennal had stated that the Department of Cardiovascular and Thoracic Surgery was started in the year 1957 along with wi.Ch. Postgraduate course (2 years). The M.Ch. training programme was started in the year 1959. At present, the Department is functioning with six Professors, twelve Assistant Professors and fifteen M.Ch. post graduates. The Department is dedicated to the teaching and training of Cardiovascular and Thoracic Surgery of the highest standard. This Department is fully equipped with the latest technology such as Video-Assisted Thoracoscopic Surgery Echocardiogram, minimally Invasive Cardiac Surgical Equipment, Bronchoscopy and Video laryndoscopy. State of art medical care is provided for a variety of cardiovascular and thoracic ailments and it serves as the tertiary referral centre for patients with complicated problems in Tamil Nadu and neighbouring States. The Out-Patients clinic is attended over 41,500 patients andually, including more than 10,000 new cases. The Department conducts over 800 major surgeries annually. Hence, he has requested to upgrade the "Department of Carcilovascular and Thoracic Surgery" at Madras Medical College, Chennal as "institute of Cardiovascular and Thoracic Surgery" and also to upgrade the post of Professor & Head of the Department into Director of Cardiovascular and Thoracio Surgery at Madras Medical College, Chennal. He has also stated that the Decariment upgradation does not require preation of any new posts except the conversion of the above post, without any financial commitment. Further the process of Logradation does not require construction of any new building or purchase of any equipment.

2. The Director of Medical Education has, therefore, requested the Government to upgrade the "Department of Cardiovascular and Thoracic Surgery" at Madras Medical College, Chennal as "Institute of Cardiovascular and Thoracic

Surgery" and also to upgrade the post of Professor & Head of the Department into Director of Institute of Cardiovascular and Thoracic Surgery at Madras Medical College, Chennal, without additional financial commitment to the Government

The Government have examined the proposal of the Director of Medical Education in detail and accord sanction for upgradation of the "Department of Cardiovascular and Thoracic Surgery at Madras Medical College, Chennai" as "Institute of Cardiovascular and Thoracic Surgery" and the existing post of Professor & Head of the Department be upgraded as Director of Institute of Cardiovascular and Thoracic Surgery at Madras Medical College, Chennai, without additional financial commitment to the Government
