ORDER:-

In the Government Order first read above, sanction was accorded for a sum of Rs.6,21,712/-(Rupees Six Lakhs Twenty One thousand Seven hundred and Twelve only) for the purchase of one new vehicle viz Mahindra & Mahindra Bolero Invader BS-2 WD/4WD for the use of the officers of the Directorate of Medical Education, along with necessary fuel allotment as per existing orders in force.

2. The Director of Medical Education, Chennai in her letter second read above has stated that Mahindra and Mahindra Bolero Invader BS-2 2WD/4WD model vehicle which was sanctioned in the Government Order first read above, is not available for procurement for use of their directorate. She has further stated that Mahindra and Mahindra vehicle of the following model viz Bolero SLE 2 WD 7 STR AC PS BS4, is available at a cost of Rs. 6,46,836/- (Rupees Six Lakhs forty six thousand eight hundred and thirty six only) at DGS&D approved rate. She has requested the Government to kindly issue orders permitting her office to purchase Mahindra and Mahindra Bolero SLE 2WD 7 STR AC PS BS4 at a cost of Rs. 7,11,520/-(including 10% escalation charges) instead of Bolero Invader BS-2 WD/4WD sanctioned in the Government Order first read above and to sanction the additional amount in the Final Modified Appropriation.

3. The Government have carefully examined the proposal of the Director of Medical Education and have decided to accept it. Accordingly in supercession of the orders issued in the Government Order first read above, sanction is accorded for a sum of Rs.7,11,520/-(Rupees Seven Lakhs Eleven Thousand and Five Hundred and Twenty only) (including 10%

escalation charges)towards the purchase of one new Mahindra and Mahindra, Bolero SLE 2WD 7 STR AC PS BS4 model vehicle for the use of the Financial Advisor and Chief Accounts Officer in the Directorate of Medical Education along with necessary fund allotment as per existing orders in force.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of account as detailed below :-

“2210- Medical and Public Health – 05- Medical Education, Training and Research – 001 – Direction and Administration – I Non Plan – AA – Directorate of Medical Education – 21 Motor Vehicles 01 Purchase.(D.P.Code 2210-05-001-AA-2110)”

5. Necessary funds required for meeting this item of expenditure, have been provided in the Final Modified Appropriation/ Final Supplementary Estimates 2015-16.
