ORDER:

In the Government Order read above, orders were issued for deemed re-employment of the Medical Officers, Nurses and Paramedical Personnel (other than Ministerial Staff) belonging to the Directorates under the control of Health and Family Welfare department, who retired on superannuation on 31.03.2020, on contract basis for a period of two months with effect from 01.04.2020 to 31.05.2020, subject to the terms and conditions for re-employment so as to meet the rising need of Medical and Paramedical Personnel to handle the present situation due to COVID-19 Pandemic in our State.

- 2. Considering the present situation of our State due to COVID-19 and to tackle the personnel requirements in Government Medical Institutions, the Government have decided to utilize the services of the Medical Officers, Nurses and other Paramedical Personnel (other than Ministerial Staff) under the control of Director of Medical Education, Director of Medical and Rural Health Services, Director of Medical and Rural Health Services (ESI), Director of Family Welfare, Director of Public Health and Preventive Medicine & Director of Indian Medicine and Homeopathy who are due to retire on superannuation in April 2020, after their retirement by giving re-employment for a period of 2 months upto 30.06.2020 and to extend the deemed re-employment ordered in the Government Order read above.
- 3. Accordingly, the Government do and hereby direct that the Medical Officers, Nurses and other Paramedical Personnel (other than Ministerial Staff) under the control of Director of Medical Education, Director of Medical and Rural Health Services, Director of Medical and Rural Health Services (ESI), Director of Family Welfare, Director of Public Health and Preventive Medicine & Director of Indian Medicine and Homeopathy who retire on superannuation on 30.04.2020, be deemed to have been re-employed on contract basis for a period of two months with effect from 01.05.2020 to 30.06.2020, subject to the terms and conditions for re-employment.

- 4. The Government also do and hereby direct that the deemed re-employment ordered in the Government Order read above to the Medical Officers, Nurses and other Paramedical Personnel (Other than Ministerial Staff) be extended upto 30.06.2020.
- 5. During the period of re-employment, the above mentioned personnel will be allowed to draw their pension in full and in addition such pay as will bring their total emoluments up to the rate of pay drawn by them at the time of retirement. In calculating emoluments, the original amount of pension shall be taken into consideration and not merely the uncommuted portion.
