ORDER:

The Mission Director, National Health Mission has reported that a proposal with a total budgetary requirement of Rs.570.00 lakh for Providing additional buildings to 9 secondary care Hospitals in High Priority Districts as detailed in Annexure to this order has been included in PIP 2013-14 which was approved by National Programme Co-ordination Committee (NPCC) of Government of India with an initial provision of Rs.171.00 lakh at 30% of total requirement of Rs.570.00 lakh for Civil works for the year 2013-14, The Executive Committee approved the same in its 24th meeting held on 08.10.2013. The amount was remitted into Government of Tamil Nadu account, under receipt head of account and the sanctioned to Public Works Department vide G.O 1st read above.

2. The Mission Director, State Health Society has added that the funds of Rs. 399 lakh, at 70% of total requirement of Rs.570.00 lakh for Providing additional buildings to 9 Secondary Care Hospitals in High Priority Districts as detailed in Annexure to this order has been approved for the year 2014-15, in the Supplementary PIP 2014-15 and the same has been remitted into Government of Tamil Nadu account, under receipt head of account vide challanNo.1063, dated: 02.02.2015 of State Bank of India , Treasury Branch, Thousand Light, Chennai.

3. The Mission Director, State Health Society has therefore, requested the Government .

- I. to sanction a sum of Rs. 399.00 lakh (Rupees Three crore ninety nine lakh only) to Public Works Department which has already been remitted into the State Government Account for execution of approved civil works for the year 2014-15 for Providing additional buildings to 9 Secondary Care Hospitals in High Priority Districts

as detailed in the Annexure to this order in addition to the sanction accorded in the G.O 1st read above.

- ii. to permit the Engineer in Chief and Chief Engineer (Buildings), Public Works Department to issue orders to the Executive Engineers of the concerned divisions for carrying out the above mentioned civil works

4. The Mission Director has further requested that the drawal of funds may be allowed in BE 2015-16 as the funds have already been remitted into Government account.

5. The Government, after careful examination, accept the proposal of Mission Director, State Health Society and accordingly,

- (i) sanction a sum of Rs.399.00 lakh (Rupees Three crore ninety nine lakh only) to Engineer in Chief and Chief Engineer (Buildings) for execution of civil works required for providing additional buildings to 9 Secondary Care Hospitals in High Priority Districts as detailed in the annexure to this order.
- (ii) the Engineer in Chief and Chief Engineer (Buildings) Public Works Department is permitted to issue orders to the Executive Engineers of the concerned divisions for carrying out the Civil Works required for providing additional buildings to 9 Secondary Care Hospitals in High Priority Districts as detailed in the annexure to this order.

6. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-

" 4211- 00 - Capital Outlay on Family Welfare -103 Maternity and Child Health - Schemes in the Twelfth Five Year Plan - III Centrally Sponsored - SA - National Component - Reproductive and Child Health Project - 16 Major works". (DPC 4211-00-103-SA-1608)
