ORDER:

The Mission Director, National Health Mission has reported that a proposal with a total budgetary requirement of Rs.3959.00 lakh for Construction of Maternity Blocks in 214 Primary Health Centres has been included in PIP 2013-14 which was approved by the NPCC of Government of India with an initial provision of Rs.1979.50 lakh at 50% of total requirement of Rs.3959.00 lakh for Civil works for the year 2013-14 and the same was approved by the Executive Committee in its, in 24th meeting held on 08.10.2013 and the amount remitted into Government of Tamil Nadu account, under receipt head of account.

2. In the G.O first read above, among the other things, an amount of 19,79,50,000/- (Rupees Nineteen crore seventy nine lakh and fifty thousand only) has been sanctioned to Chief Engineer (Buildings) Public Works Department for the above civil works mentioned in para 1 above.

3. The Mission Director, State Health Society has further reported that due to the revision of schedule of rates and inclusion of certain additional works required for overall improvement to the buildings, the cost of construction in respect of Maternity Blocks was revised from Rs.18.50 lakhs to Rs.23.00 lakh per each Block with escalation cost of Rs.4.50 lakh . Hence, a proposal for cost of escalation for the said civil works had been included in the 2nd Supplementary PIP 2013-14 and the NPCC of Government of India approved the proposal in principle and with budgetary provision in the year 2014-15.

4. The Mission Director, State Health Society has added that the fund amounting a total sum of Rs.2942.50 lakh, for above mentioned civil works has been approved for the year 2014-15, included in the Supplementary Record of Proceedings (ROP) 2014-15, and the amount released by the Government of India remitted into Government of Tamil Nadu account, under receipt head of account. vide challan No.1133, dated 09.02.2015 of State Bank of India Branch, Thousand Light, Chennai.

5. The Mission Director, State Health Society has therefore, requested the Government;-

- I. to permit him to revise the construction cost of Maternity Blocks from 18.50 lakh to Rs.23.00 lakh as per the National Programme Co-ordination Committee (NPCC) approval and execute the civil works through Public Works Department,
- ii. to sanction a sum of Rs. 2942.50 lakh (Rupees Twenty nine crore forty two lakh and fifty thousand only) to Public Works Department which has already been remitted into the State Government Account for execution of approved civil works (construction of Maternity blocks) in 214 Primary Health Centres in addition to amount of Rs.1979.50 lakh (Rupees Nineteen crore seventy nine lakh and fifty thousand only) already sanctioned in the G.O 1st read above.
- iii. to permit the Engineer in Chief (Buildings), Public Works Department to issue orders to the Executive Engineers of the concerned divisions for carrying out the above work and to allow the drawl of funds in BE 2015-16 under the Head of Account "4211 -00 outlay on Family Welfare".

6 . The Government, after careful examination, accept the proposal of Mission Director, State Health Society and accordingly,

- (i) permit him to revise the construction cost of Maternity Blocks from 18.50 lakh (Rupees Eighteen lakh and fifty thousand only) to Rs.23.00 lakh (Rupees Twenty three lakh only) as per the National Programme Co-ordination Committee (NPCC) approval for carrying out the civil works through Public Works Department,
- (ii) sanction a sum of Rs. 2942.50 lakh (Rupees Twenty nine crore forty two lakh and fifty thousand only) to the Engineer in Chief and Chief Engineer Buildings, Public Works Department, Chennai -5 for execution of civil works for construction of maternity blocks in 214 Primary Health Centres in addition to the amount of Rs.1979.50 lakh (Rupees Nineteen crore seventy nine lakh and fifty thousand only) already sanctioned in G.O 1st read above
- (iii) the Engineer in Chief and Chief Engineer (Buildings) Public Works Department is permitted to issue orders to the Executive Engineers of the concerned divisions for carrying out the Civil Works required for construction of Maternity Blocks in 214 Primary Health Centres. The Public Works

Department is permitted to execute the works as per the authorization issued from the State Health Society.

6. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-

" 4211- 00 - Capital Outlay on Family Welfare -103 Maternity and Child Health – Schemes in the Twelfth Five Year Plan – III Centrally Sponsored – SA – National Component – Reproductive and Child Health Project – 16 Major works". (DPC 4211-00-103-SA-1608)
