ORDER:

In the Government Order first read above, the Government ordered for establishing Multi Super Speciality Hospital in the newly constructed Secretariat Complex at Omandurar Government Estate and in the Government Order second read above, among others, sanction has been accorded for an amount of Rs.26.90 crores for modification work.

The Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital in his letter has stated the Tamil Nadu Government Multi Super Speciality Hospital was inaugurated through Video Conferencing by the Hon'ble Chief Minister of Tamil Nadu on 21.02.2014. The General Manager, ELCOT Corporation, has forwarded the invoice for Rs.2,94,472/- towards cost of arranging Video Conferencing System with accessories for inauguration of Tamil Nadu Government Multi Super Speciality Hospital, Omandurar Government Estate, Chennai. He has also stated that the claim is for the following activities:

- a. supply and commissioning of video conferencing system with accessories used at the Multi Super Speciality Hospital function site.
- b. Supply and commissioning of Video Conferencing system with accessories at Press Conference Room, Secretariat on sharable basis used for two departments.
- c. Dedicated 2 Mbps leased line connectivity through BSNL from Multi Super Speciality Hospital function site to Network operating centre, Perungudi alongwith redundant connectivity.
- d. 16 Mbps leased line connectivity through BSNL from Network operating centre, Perungudi to Press Conference Room, Secretariat on pro-rate basis used by two departments for the inaugural event.
- 3. The Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital has requested the Government to sanction a sum of Rs.2,94,472/- towards the cost of arranging Video Conferencing System with accessories for inauguration of the Tamil Nadu Government Multi Super Speciality Hospital, Omandurar Government Estate, Chennai.
- 4. The Government have examined the proposal of the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital in detail and accordingly sanction a sum of Rs.2,94,472/- (Rupees Two Lakhs Ninety Four Thousand Four Hundred and Seventy Two only) towards the cost of arranging Video Conferencing System with accessories for inauguration of the Tamil Nadu Government Multi Super Speciality Hospital, Omandurar Government Estate, Chennai.
- 5. The expenditure sanctioned in para 4 above, shall be debited to the following head of account:

- 6. Necessary funds will be provided in the RE/FMA 2014-2015. Pending provision of funds in RE/FMA 2014-15 the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital is authorized to draw and disburse the amount sanctioned in para 4 above. The Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital is requested to include this expenditure, while sending the budget proposal for Revised Estimates / Final Modified Appropriation 2014-2015 to Government in Finance (Health-II) Department without fail.
