## ORDER:

The Mission Director, National Health Mission has reported that the proposal for the construction of new buildings for 39 Health Sub Centres with a total budgetary requirement of Rs.585.00 lakh had been included in PIP 2013-14 and approved by the NPCC of Government of India with a initial provision of Rs.292.50 lakhs at 50% of total requirement of Rs.585.00 lakh for Civil works for the year 2013-14.

2. The Mission Director, State Health Society has further reported that , due to the revision of schedule of rates and inclusion of certain additional works required for overall improvement to the buildings, the cost of construction in respect of HSCs was revised from Rs.15.00 lakh to Rs.18.00 lakh each. Hence, a detailed proposal for cost escalation for civil works had been included in the 2<sup>nd</sup> Supplementary PIP 2013-14 and approved by the National Programme Co-ordination Committee (NPCC) of Government of India in supplementary ROP 2014-15 at 50% of Rs 15.00 lakhs each and cost escalation of Rs.3.00 lakh each as follows;

- 3. The Mission Director, State Health Society has added that the funds amounting a sum of Rs.409.50 lakh, for construction of civil works in 39 Health Sub Centres has been approved for the year 2014-15, and the same has been remitted into Government of Tamil Nadu account, under receipt head of account vide challan No.1058, dated: 02.02.2015 of State Sank of India, Treasury Branch, Thousand light, Chennai.
- 4. The Mission Director, State Health Society has therefore, requested the Government.
  - To revise the cost for construction of Buildings for 39. Health Sub Centres from 15.00 lakh to 18.00 lakh leach
- to sanction a sum of Rs. 409.50 lakh (Rupees Four crore nine lakh and fifty thousand only) to Engineer in Chief and Chief Engineer (Buildings). Public Works Department approved for the year 2014-15 and remitted into the Government account, in addition to the funds of Rs.292.50 lakhs sanctioned in the Government Order first read above for execution of Civil Works, for the construction of 39 new HSC buildings, at the revised rate of Rs.18.00 lakhs, in the High Priority Districts.
- III. to permit the Engineer in Chief and Chief Engineer (Buildings), Public Works Department to issue orders to the Executive Engineers of the concerned divisions for carrying out the above work and drawl of funds in BE 2015-16 under the Head of Account "4211 -00 outlay on Family Welfare".
  - 5. The Government, after careful examination, accept the proposal of Mission Director, State Health Society and accordingly,
    - I. permit the Mission Director, State Health Society to revise the cost for construction of buildings for 39 Health Sub Centres from Rs. 15 lakhs to Rs. 18 lakhs.
    - II. sanction a sum of Rs. 409.50 lakhs (Rupees Four crore nine lakh and fifty thousand only) approved for the year 2014-15 and remitted into the Government account, in addition to the funds Rs.292.50 lakhs sanctioned in the Government Order 1<sup>st</sup> read above for execution of Civil Works relating to

the construction of 39 new HSC buildings, at the revised rate of Rs.18.00 lakhs, (Rupees eighteen lakh only) in the High Priority Districts.

- III. the Engineer in Chief and Chief Engineer (Buildings) Public Works Department is permitted to issue orders to the Executive Engineers of the concerned divisions for carrying out the Civil Works required for construction of Buildings for 39 Health Sub Centres.
- 6. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-
  - "4211- 00 Capital Outlay on Family Welfare -103 Maternity and Child Health Schemes in the Twelfth Five Year Plan III Centrally Sponsored SA National Component Reproductive and Child Health Project 16 Major works". (DPC 4211-00-103-SA-1608)
