## ORDER:

In Government Order first read above, orders have been issued for starting of a Government Siddha Medical College at Palani in Dindigul District from the Academic year 1985-1986 for conducting of the BSM&S course and the college was shifted from Palani to Chennai and located in the campus of Arignar Anna Government Hospital of Indian Medicine, Chennai vide Government Order second read above. In Government Order third read above, orders have been issued to increase the number of seats from 22 to 50 in B.H.M.S Course in the Government Homoeopathy Medical College, Thirumangalam, Madurai District from the year 1996-1997. In Government Order fourth read above, orders have been issued for establishment of a new Government Ayurveda Medical College at Kottar, Nagercoil, with annual intake capacity of fifty seats in Ayurvedachrya (BAMS) Course from the academic year 2009-2010.

2. The Commissioner of Indian Medicine and Homoeopathy in her letter 5<sup>th</sup> read above has stated that as per the latest revised regulations of Central Council of Indian Medicine, New Delhi vide Notification dated: 19.2.2013 (Siddha-BSMS) and Notification dated: 18.7.2012 (Ayurveda–BAMS) and as per the latest revised regulations of Central Council of Homoeopathy, New Delhi (Homoeopathy-BHMS) the minimum standard requirement for grant of permission is one and the same for both 50 seats intake as well as 60 seats. Since the above three Government ISM Colleges

have fulfilled the minimum standard requirements as laid down by Central Council of Indian Medicine and Central Council of Homoeopathy, New Delhi and no additional expenditure will be incurred for the increase of students strength, the Commissioner of Indian Medicine and Homoeopathy has requested the Government to issue 'No Objection Certificate' for increase of sanctioned strength from 50 seats to 60 seats for the each of the above three Government ISM Medical Institutions from the current academic year 2014-2015.

- 3. The Government after careful examination have decided to accept the proposal of the Commissioner of Indian Medicine and Homoeopathy, Chennai and permit her to increase the intake capacity of Government Siddha Medical College, Chennai, Government Ayurveda Medical College, Kottar, Nagercoil and Government Homoeopathy Medical College, Thirumangalam, Madurai from 50 to 60 (Fifty to Sixty) seats from the Academic Year 2014-2015 and accordingly issue 'No Objection Certificate' to this effect for the above three Medical Institutions.
- 4. The Commissioner of Indian Medicine and Homoeopathy is directed to take action accordingly.
