ORDER:-

In Government order first read above, among others, one post of Assistant Professor in the Rheumatic Care Unit, Madras Medical College was converted into that of Reader in Medicine and Rheumatology, Madras Medical College.

2. The Director of Medical Education has stated that the Department of Rheumatology has been started in the Institution during the year 1972. The said department was started with the bed strength of 30 and additional 10 beds under Chief Minister's Health Insurance Scheme. The statistics reveals that there is increase in the new cases and the old cases needs the regular follow up. Due to scientific advancement in Rheumatology, lots of innovations and research are to be carried out as routine in the Department of Rheumatology. The advancement of the technology and research that requires the upgradation of the Department of Rheumatology as Institute.

3. The Director of Medical Education has therefore requested the Government to upgrade the Department of Rheumatology, Madras Medical College/Government General Hospital, Chennai as an Institute of Rheumatology and upgrade one post of Professor as Director to provide better treatment to poor patients coming to the Government Hospital.

4. The Director of Medical Education has also stated that the additional financial implication involved for upgrading the existing Department of Rheumatology, Madras Medical College/Government General Hospital, Chennai as an Institute of Rheumatology and upgrading the

existing one post of Professor as Director in the Institute of Rheumatology will be Rs.2556/- per annum.

5. The Government have examined the proposal of the Director of Medical Education and accord sanction for upgradation of the existing Department of Rheumatology, Madras Medical College/Government General Hospital, Chennai as an "Institute of Rheumatology" and for upgradation of the existing one post of Professor (scale of pay of Rs.37400-67000 with Grade of Pay of Rs.8700) in the department sanctioned vide Government order first read above into that of "Director" in the scale of pay of Rs.37400-67000 with Grade of Pay of Rs.8800- in the upgraded Institute of Rheumatology.

6. The expenditure towards pay and allowances for the post shall be debited to the following Head of Account:-
