ORDER:

The Mission Director, National Health Mission has reported that the proposal for construction of 6th and 7th floor in the Director of Medical and Rural Health Services Annex Building for housing O/o. State Health Society , Tamil Nadu has been included in PIP 2013-14 which was approved by National Programme Co-ordination Committee of the Government of India with an initial provision of Rs.99.00 lakh at 20% of total requirement of Rs.495.00 lakh for Civil works for the year 2013-14 and the same has been approved in the 24th Executive Committee meeting held on 08.10.2013, vide agenda No.28. The amount of Rs.99 lakh released by the Government of India has been remitted into Government of Tamil Nadu account, under receipt head of account and sanctioned to the Public Works Department in the G.O first read above.

2. The Mission Director, State Health Society has added that the fund amounting a sum of Rs.99.00 lakh, at 20% of total requirement of Rs.495.00/- lakh for the above mentioned civil works has been approved for the year 2014-15, included in the Supplementary PIP 2014-15 and the amount released by the Government of India

has been remitted into Government Treasury, under receipt head of account vide challan No. 1073, dated: 02.02.2015 of State Bank of India, Treasury Branch, Chennai-6.

3. The Mission Director, State Health Society has therefore, requested the Government .

- i. to sanction a sum of Rs. 99.00/- lakh (Rupees Ninety nine lakh only) to Public Works Department which has already been remitted into the State Government Account for execution of approved civil works for the year 2014-15 for construction of 6th and 7th floor in the Director of Medical and Rural Health Services Annex building for housing State Health Society in addition to the amount of Rs.99 lakh /- (Ninety nine lakh only) already sanctioned in G.O.(Ms).No.281, Health and Family Welfare (EAP II-2) Department, dated: 02.12.2013
- ii. to permit the Engineer in Chief (Buildings), Public Works Department to issue orders to the Executive Engineer of the concerned divisions for carrying out the above work and to allow drawl of funds in BE 2015-16.

4. The Mission Director, State Health Society has also requested to allow the drawal of funds from the provisions of BE 2015-16, as the funds have already been remitted into the Government account.

5. The Government, after careful examination, accept the proposal of Mission Director, State Health Society and accordingly, sanction an amount of Rs. 99.00/- lakh (Rupees Ninety nine lakh only) to the Engineer in Chief (Buildings), Public Works Department in addition to the amount of Rs.99/- lakh (Rupees Ninety nine lakh only) already sanctioned vide G.O 1st read above for construction of 6th and 7th floors of the Director of Medical and Rural Health Services Annex building, for housing O/o State Health Society , Tamil Nadu by availing funds already remitted into the State Government Account .

6. The Engineer in Chief (Buildings), Public Works Department is permitted to issue orders to the Executive Engineers of the concerned Division for carrying out the work sanctioned in para 5 above.

7. The expenditure sanctioned in para 5 above shall be debited to the following Head of account:-

“ 4211-00 - Capital Outlay on Family Welfare -103 Maternity and Child Health – Schemes in the Twelfth Five Year Plan – III Centrally Sponsored – SA – National Component – Reproductive and Child Health Project – 16 Major works”. (DPC 4211-00-103-SA-1608)
