ORDER:

In the letter first read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share towards Release of Grants-in-Aid for Flexible Pool for Non - Communicable Diseases during 2017-18 as detailed below:-

2. The corresponding 40% of the State Share against the 60% of the Government of India release of Rs. 4,89,00,000/- (Rupees Four crore and eighty nine lakh only) works out of Rs. 3,26,00,000/-(Rupees Three Crore and Twenty six lakh only).

3. In the Government Order second read above, the Government of India Share of Rs.4,89,00,000/-(Rupees four crore and eighty nine lakh only) was sanctioned.

4. The Mission Director, State Health Society has therefore requested to issue orders for the release of a sum of Rs.3,26,00,000/- (Rupees three crore and twenty six lakh only) towards the State Share for Grants-in-Aid for Flexible Pool for

Non- Communicable Diseases during 2017-18 to the State Health Society and to authorize the Mission Director to draw the above amount under National Health Mission through Treasury mode and credit into State Health Society Account.

5. Accordingly, the Government sanction a sum of Rs.3,26,00,000/- (Rupees three crore and twenty six lakh only) being the State Share for Grants-in-Aid for Flexible Pool for Non-Communicable Diseases during 2017-18.
