The Registrar, Dr. M.G.R Educational and Research Institute University,

seats in the following 4 MDS courses in Thai Moogambikai Dental College and Hospital,
Mugappair, Chennai from the academic year 2014 – 2015.

2. The Director of Medical Education was directed to cause an inspection at the premises of the Thai Moogambikai Dental College and Hospital, Mugappair, Chennai with reference to the Dental Council of India norms and send the inspection report along with her specific recommendations.

3. The Director of Medical Education has nominated inspection teams for conducting inspections and sent her recommendations about the desirability and feasibility for increase of MDS seats along with the reports and compliance verification reports of the Inspection team.

4. The Government after verifying the desirability and feasibility, convey permission / Essentiality Certificate for increase of annual intake of seats in the following 4 specialties in MDS courses in Thai Moogambikai Dental College and Hospital, Mugappair, Chennai from the academic year 2014 – 2015 as noted against each specialty, subject to condition that the approval of Government of India / Dental Council of India should be obtained before admitting students to the increased seats and the approval of CMDA should be obtained in due course:

- i) Periodontics - from 2 to 6 seats
- ii) Conservative Dentistry and Endodontics - from 2 to 6 seats
- iii) Oral & Maxillofacial Surgery - from 2 to 6 seats
- iv) Prosthodontics and Crown Bridge - from 2 to 6 seats
