### ORDER:

The Chairman, Annai Sri Aurobindo Educational Trust has requested Government to grant permission for change of site of "Sri Aurobindo School of Nursing" from Athur Village to a new site at TNPL Road, Punnamchatram, Karur District.

The Director of Medical Education has constituted an inspection team to verify as to whether the proposed College of Nursing, at the new site has fulfilled the conditions prescribed by the Government and the Indian Nursing Council, New Delhi and submitted the proposal along with the Inspection report / Project Report along with her specific recommendations to the Government and requested Government to issue necessary orders for the change of site from Athur Village to a new site at TNPL Road, Punnamchatram, Karur District.

3. The Government have examined the case in detail in the light of the recommendation in the Inspection Report and that of the Director of Medical Education and accepted the request of the Annai Sri Aurobindo Educational Trust and permit the said Trust to change the site of "Sri Aurobindo School of Nursing" from Athur Village to 'TNPL Road, Punnamchatram, Karur District' to conduct DGNM course from the academic year 2014-2015, subject to the following conditions:-

- a) The Trust should obtain recognition / suitability / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, Indian Nursing Council, New Delhi and Tamil Nadu Dr. M.G.R. Medical University respectively for the new address.

b) The Trust should not run any other Nursing institution within 10 kms radius.
