ORDER:

The Thirteenth Finance Commission under the Scheme "Health infrastructure" has recommended a grant of Rs.200.00 crores to Tamil Nadu to provide infrastructure in public hospitals including construction of health centres and water analysis laboratories and purchase of diagnostic equipments.

- 2. The Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital, Chennai has forwarded a proposal for the provision of Intra Vascular Ultra Sound and Freezer box at a cost of Rs.86 lakhs to the Tamil Nadu Government Multi Super Speciality Hospital, Chennai.
- 3. On the above, the High Level Monitoring Committee has approved the proposal for provision of Intra Vascular Ultra Sound at a cost of Rs.82 lakhs to the Tamil Nadu Government Multi Super Speciality Hospital, Chennai from out of the savings made in the 13th Finance Commission grants in respect of Health and Family Welfare Department under the scheme 'Health Infrastructure'. In respect of provision of freezer box, the High Level Monitoring Committee (HLMC) has decided that the same may be considered if the Health and Family Welfare Department comes up with savings if any available from out of sanctions already made towards other schemes.

- 4. The Government, after considering the approval of High Level Monitoring Committee have decided to accept the proposal of the Officer on Special Duty, Tamil Nadu Government Multi Super Speciality Hospital, Chennai and accord sanction for purchase of one Intra Vascular Ultra Sound at a cost of Rs.82.00 lakhs (Rupees Eighty Two Lakhs only) to the Tamil Nadu Government Multi Super Speciality Hospital, Chennai from out of the savings available under State Specific Needs Grant recommended by 13th Finance Commission (Health Infrastructure).
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

2210 – Medical and Public Health – 80 General - 800 other Expenditure schemes in the Twelfth Five Year Plan II State Plan – JH Improvement of Health Infrastructure by using 13th Finance Commission Grant 19 Machinery and Equipments – 01 purchase.

(2210 - 80 - 800 - JH 1917)

- 6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of legislature will be obtained in due course. Pending approval of legislature the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from the Contingency Fund will be issued by Finance (BG-II) Department. The Director of Medical Education shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this orders to Finance (BG.I) Department. The Director of Medical Education shall also send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2014-15 to Finance (Health II/BG.I) Department at the appropriate time without fail.
- 7. The Director of Medical Education is directed to procure and install the above item through Tamil Nadu Medical Service Corporation Limited.
- 8. The Director of Medical Education is further informed that the amount shall not be paid in cash but credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited by means of Cheque / Demand Draft in favour of Personal Deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited:
