#### ORDER:

The Commissioner of Indian Medicine and Homoeopathy has stated that the Principal (i/c), Government Siddha Medical College, Palayamkottai, Tirunelveli has requested to provide a Digital X-ray Machine to the College Hospital and also stated that every year nearly 3.65 lakh patients are taking treatment in the OP and IP Department at Government Siddha Medical College Hospital, Palayamkottai, Tirunelveli. The existing machine has become obsolete and to make correct diagnosis, the above equipment is inevitable.

2. The Commissioner of Indian Medicine and Homoeopathy has therefore requested the Government to accord sanction of Rs.15.00 lakh for the procurement of the Digital X-ray machine to the Government Siddha Medical College Hospital, Palayamkottai, Tirunelveli.

3. During the Budget session 2014-2015 on the floor of the Assembly, the Honourable Minister (Health) announced to provide a Digital X-ray for the Government Siddha Medical College, Palayamkottai, Tirunelveli at a cost of Rs.15.00 lakhs.

4. Accordingly, the Government have decided to accept the proposal of the Commissioner of Indian Medicine and Homoeopathy and accord sanction for a sum of Rs.15,00,000/- (Rupees fifteen lakh only) for purchase of one Digital X-ray machine to the Government Siddha Medical College Hospital, Palayamkottai, Tirunelveli .

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:

6. The above expenditure shall constitute an item of "New Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund. Orders regarding the sanction of advance from the Contingency Fund will be issued by the Finance (BG.I) Department separately. The Commissioner of Indian Medicine and Homoeopathy is requested to send necessary proposals to Government in Finance (BG.I) Department in the prescribed format along with a copy of this order for sanction of an advance from the Contingency Fund. He is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2014-2015, to Finance (B.G.I/Health-I) Department at the appropriate time without fail.
