ORDER:

In the Government order first read above, among others, an amendment to the Special Rules for the Tamil Nadu Public Health Subordinate Services for the educational qualification for the post of Statistical Assistant was issued.

2. In their letter second read above, the Tamil Nadu Public Service Commission has stated that the Advertisement No.252, dated 08.11.2010 has been issued for filling up of the post of Statistical Assistant. As per the Educational Qualification for the said post, a candidate who has studied other than Statistics should have studied Statistics as an ancillary or allied or special subject and that while scrutinizing the applications, the eligibility of the candidates with reference to Educational Qualification could not be ascertained since many Universities are awarding degrees in different names with different curriculum and syllabus and it becomes very difficult to come to a definite conclusion as to whether the qualification referred to above may be accepted or not. After conducting a meeting, the Commission recommended to the Government that the educational qualification for the post of Statistical Assistant shall be a Post Graduate Degree in Statistics or Bio-Statistics and requested the Government to amend rule 5 of the Special Rules for Tamil Nadu Public Health Subordinate Service with reference to the post of Statistical Assistant.

- 3. In his letter third read above, the Director of Public Health and Preventive Medicine has submitted a proposal to the Government and requested the Government to issue necessary amendment to the existing Special Rules for the Tamil Nadu Public Health Subordinate Services (Section 26 in Volume III of Tamil Nadu Services Manual, 2016) to the post of Statistical Assistant.
- 4. The Government have examined the proposal of the Director of Public Health and Preventive Medicine in the light of the views of the Tamil Nadu Public Service Commission and decided to accept the same and to issue suitable amendment to the Special Rules for the post of Statistical Assistant. Accordingly, a draft notification for amending the Special Rules for Tamil Nadu Public Health Subordinate Service has been sent to the Tamil Nadu Public Service Commission for obtaining its concurrence. In its letter fourth read above, the Commission has given its concurrence for amending the Special Rules for Tamil Nadu Public Health Subordinate Service.
- 5. The Government have again examined the proposal and decided to amend the Special Rules for Tamil Nadu Public Health Subordinate Service for the post of Statistical Assistant. The Government accordingly do and hereby direct that the amendment to the Special Rules be issued in the Notification appended to this Government Order and it shall be published in the <u>Tamil Nadu Government Gazette</u>.

NOTIFICATION -

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Public Health Subordinate Service. (Section 26 in Volume III of the Tamil Nadu Services Manual, 2016).

AMENDMENT.

In the said Special Rules, in the Annexure (referred to in rule 5(b)), under the heading "Class I", for item (ii) in column (2) against the entry "Statistical Assistant" in column (1) thereof, the following item shall be substituted, namely:-

"(ii) For appointment by direct recruitment - A post graduate degree in Statistics or Bio-Statistics".
