From the Secretary, Government of India, Department of Health and Family Welfare, Ministry of Health and Family Welfare, dated 17.4.2014.

ORDER:-

The Secretary to Government of India, Department of Health and Family Welfare, Ministry of Health and Family Welfare has forwarded "Guidelines and Examination Proforma for Medico legal cases of victims of Sexual Violence," drawn up by the Ministry in consultation with a host of medical and legal experts in the field of sexual violence, and administrative experts. The Secretary, Government of India has stated that the aim behind the guidelines is to bring about certain degree of uniformity in approaching, treating and documenting cases of sexual violence, especially rape. He has also stated that the purpose of uniformity, is to set to the course for more sensitive and humane approach to victims of sexual assault / rape when they arrive in hospitals, their effective treatment at the hospitals and proper recording and documentation of medical history and facts by the treating doctor. All three components are important but the last one should ensure a higher conviction rate in such cases.

- 2. Further the Secretary, Government of India has stated under the amended criminal law, sexual assault survivors and victims cannot be denied treatment in a hospital whether private or Government. It is thus a mandatory obligation. If not, fulfilled it could set the law in motion against the offending hospitals and doctors with likely penal consequences. The Secretary has requested to adopt the guidelines in all hospitals in the State. - 3. The Government after careful examination adopt the "Guidelines and Examination Proforma for Medico legal cases of victims of Sexual Violence," prescribed by Government of India and instruct the Heads of Department to adhere the same in all Government Medical Institutions.
