The corresponding 40% of the State Share against the 60% of the Government of India release Rs.183,29,13,000- (Rupees One hundred and eighty three crore twenty nine lakh and thirteen thousand only) works out Rs.122,19,42,000- (Rupees One hundred and twenty two crore nineteen lakh and forty two thousand only).
- 3. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.122,19,42,000- (Rupees One hundred and twenty two crore nineteen lakh and forty two thousand only) towards the Release of Grants-in-aid for Liquidation of Arrears of 2015-16 for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during 2018-19 as mentioned above and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw a sum Rs.122,19,42,000- (Rupees One hundred and twenty two crore nineteen lakh and forty two thousand only) under National Health Mission and credit into State Health Society Account.

The Government after careful consideration have decided to accept the above proposal of the Mission Director State Health Society and accordingly sanction a sum of Rs.122,19,42,000- (Rupees One hundred and twenty two crore nineteen lakh and forty two thousand only) towards the State Share contribution of Grants-in-Aid for Release of Grants-in-aid for Liquidation of Arrears of 2015-16 for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during 2018-19 under National Health Mission.
