ORDER:

In the letter first read above, the Mission Director, National Health Mission has stated that Directorate of Family Welfare have intimated the Principal Accountant General, Chennai that Government of India have issued sanction orders towards the Cost Adjustment (Kind Grant) of supply of vaccines under Routine Immunization and requested to book in the accounts of the A.G. as expenditure by way of book adjustment. The Government of India share of the vaccines supplies under Routine Immunization Programme (Reproductive and Child Health) during 2017-2018 as detailed below:-

The Government of India have sanctioned a sum of Rs.16,64,69,000/-(Rupees Sixteen crore sixty four lakh and sixty nine thousand only) as per its Cost Adjustment of the Vaccines supplies under Routine Immunization Programme (Reproductive and Child Health) during 2017-18 and Director of Family welfare have booked for above expenditure in the book of AG the amount of State share for Kind Grant have to be drawn from State Budget.
- 3. The corresponding 40% of the State Share against the 60% of the Government of India release of Rs.16,64,69,000/- (Rupees Sixteen crore sixty four lakh and sixty nine thousand only) relating to the year 2017-18 works out to Rs. 11,09,79,333/- (Rupees Eleven crore nine lakh seventy nine thousand three hundred and thirty three only).
- 4. The Mission Director, National Health Mission has therefore Stated that Director of Family Welfare have booked for the above expenditure in the book of Accountant General and requested to issue orders for the release of a sum of Rs.11,09,79,333/- (Rupees Eleven crore nine lakh seventy nine thousand three hundred and thirty three only) towards State Share against the Government of India Cost Adjustment of the Vaccines supplies under Routine Immunization Programme (Reproductive and Child Health) during 2017-18 as mentioned above—and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw a sum of Rs.

11,09,79,333 (Rupees Eleven crore nine lakh seventy nine thousand three hundred and thirty three only) under National Health Mission through Treasury mode.

5.Accordingly, the Government sanction a sum of Rs. 11,09,79,333 (Eleven crore nine lakh seventy nine thousand three hundred and thirty three only) being the State Share against the Government of India Cost Adjustment of the Vaccines supplies under Routine Immunization Programme (Reproductive and Child Health) during 2017-18
