ORDER:

In the letter read above, the Missicn Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share of Grants-in-Aid for 1st Installment of Infrastructure Maintenance under National Health Mission during 2018-19. The details are as follows:-

- 2. The corresponding 40% of the State Share against the 60% of the Government of India release Rs.31,33,03,000/- (Rupees Thirty one crore thirty three lakh and three thousand only) works out Rs.20,88,68,667/- (Rupees Twenty crore eighty eight lakh sixty eight thousand six hundred and sixty seven only).
- 3. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.20,88,68,667/- (Rupees Twenty Crore Eighty Eight Lakh Sixty Eight Thousand Six Hundred and Sixty Seven Only) towards the State Share of Grants-in-aid for 1st Installment of Infrastructure Maintenance during 2018-19 as mentioned above and to authorize him, to draw a sum Rs.20,88,68,667/-

(Rupees Twenty crore eighty eight lakh sixty eight thousand six hundred and sixty seven only)under National Health Mission and credit it into State Health Society Account.

- 4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.20,88,68,667/- (Rupees Twenty crore eighty eight lakh sixty eight thousand six hundred and sixty seven only) towards the State Share contribution of Grants-in-Aid for 1st Installment Infrastructure Maintenance during 2018-19 under National Health Mission.
