ORDER:-

The Director of Medical Education has reported that the Central Library attached to the Tamil Nadu Government Dental College and Hospital, Chennai is functioning with one post of Librarian since its separation from the Madras Medical College, Chennai. At that time the annual intake of students for Under Graduate was 45 and annual intake of students for Post Graduate was 20. Now the intake has been increased for under graduates from 45 to 100 and for post graduates from 20 to 40. The total strength of the students has doubled and their utility of library has also increased phenomenally. More number of books and journals are being purchased every year, but managed by one post of Librarian with great difficulty. Further, “e-library” established in this college with 10 computers and net connection in December 2013 attracts both the undergraduate and postgraduate students to visit the library often. It is also proposed to subscribe for e-journals and if so more number of post graduate students will use the e-library. Due to shortage of library staff, the library is now functioning from 12.00 noon to 7.00 p.m. only. The students and faculty could make use of the library fully, if the library functions from 8.00 a.m to 8.00 p.m daily.

2. The Director of Medical Education has therefore requested the Government to create the following additional posts to the Tamil Nadu Government Dental College and Hospital, Chennai:-

Librarian	2 posts (one post of PG and one post of UG)
Library Assistant	2 posts (one post of PG and one post of UG)
Library Attendant	2 posts
Sweepers and Scavengers	2 posts
Total	8 posts

3. The Government have examined the proposal of the Director of Medical Education in detail and accord sanction for creation of one post of Library Assistant in time scale of pay of Rs.5200-20200 with Grade Pay Rs.2400 and one post of Library Attendant in time scale of pay of Rs.4800-10000 with Grade Pay Rs.1300 to the Tamil Nadu Government Dental College and Hospital, Chennai at an average annual recurring cost of Rs.6,12,792/- (Rupees Six Lakh Twelve Thousand Seven Hundred and Ninety Two only), for the period of one year from the date of filling up of the post.

4. The expenditure sanctioned for the posts in para 3 above, shall be debited to the following head of account:

“2210 – Medical and Public Health 01 – Urban Health Services - Allopathy – 110 Hospitals and Dispensaries - I Non Plan AX – Government Dental College and Hospital - 01 Salaries.
(DPC - 2210 - 01-110 - AX - 0100)”.

5. Necessary additional funds of Rs.3,57,467/- will be provided in RE/ FMA 2015-16. Pending provision of such funds in RE/FMA 2015-16, the Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 3 above. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for RE/FMA 2015-16 to Government in Finance Health –II Department without fail.
