## ORDER:

As per the announcement made by the Hon'ble Chief Minister of Tamil Nadu on the floor of the Assembly that a "Multi Super Speciality Hospital" on par with AIIMS and a Medical College will be started on Omandurar Government Estate, Chennai. Orders have been issued in the Government order first read above, to utilize 'Block A' of the newly constructed building at Omandurar Government Estate as a Multi Super Speciality Hospital and to utilize 'Block B' to start a new Government Medical College. The Tamil Nadu Government Multi Super Speciality Hospital at Omandurar Government Estate, Chennai was inaugurated by the Hon'ble Chief Minister through video conferencing on 21.02.2014.

- 2. M/s. Excellent '2' Publicities has sent an invoice for Rs.1,74,02,589/-towards advertisement charges for publishing of advertisement regarding opening of the Tamil Nadu Government Multi Super Speciality Hospital at Omandurar Government Estate, Chennai in the Newspapers and enclosed a copy of the Release Order dated 20.02.2014 issued by the Director of Information and Public Relation in its favour.
- 3. The Government after careful consideration decided to accept the request of M/s Excellent '2' Publicities, Chennai-2. Accordingly Government sanction a sum of Rs.1,74,02,589/-(Rupees One Crore Seventy Four Lakh Two Thousand Five Hundred and Eighty Nine only) towards payment of advertisement charges for publishing advertisement in connection with the inauguration of the Tamil Nadu Government Multi Super Speciality Hospital

at Omandurar Government Estate, Chennai after deducting Income Tax at source as calculated below:-

Pending approval of the Legislature, the expenditure will be initially met by sanction of an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG.I) Department separately. The Officer on Special Duty, Multi Super Speciality Hospital, Chennai -2 is requested to send necessary proposal to Government in Finance (BG-1) Department in the prescribed format along with a copy of this order for sanction of an advance required for the current year from Contingency Fund. He is also requested to send a draft explanatory notes for including the above expenditure in the Final Supplementation Estimate 2014-15 to Finance (BG.I) Department without fail.
