ORDER:

In the Government Order second read above, orders were issued to permit the Commissioner, Food Safety and Drug Administration Department to purchase a new Maruthi Ertiga Model Car (Petrol) as a special case and accordingly, a sum of Rs. 6,43,976/- (Rupees six lakh forty three thousand nine hundred and seventy six only) was sanctioned.

- 2. In the letter third read above, the Commissioner, Food Safety and Drug Administration Department, has requested sanction of a sum of Rs. 17,284/- as a difference amount to be paid towards purchase of vehicle, due to increase on the price of the vehicle at the time of purchase.
- 3. The Government after careful examination, sanction a sum of Rs. 17,284 (Rupees seventeen thousand two hundred and eighty four only) to the Commissioner, Food Safety and Drug Administration Department, as a difference of amount to be paid to Popular vehicle and services limited, Chennai.
- 4. The expenditure sanctioned in para 3 above shall be debited under the following head of account:-

"2210 – Medical and Public Health – 06 – Public Health – 001- Direction and Administration – I Non Plan – AH – Food Safety Wing – Headquarters Administration – 21 Motor vehicle 01 purchase".

- 5. Necessary additional fund will be provided in Final Modified Appropriation 2015-2016. Pending provision of funds in the Revised Estimate 2015-2016, the Commissioner, Food Safety and Drug Administration Department is authorized to incur the amount sanctioned in para 3 above. The Commissioner Food Safety and Drug Administration Department is directed to include the expenditure while sending the Budget proposal for Final Modified Appropriation 2015 -2016 to Government in Finance (Health I) Department without fail.
- 6. This order issues with the concurrence of Finance Department vide its U.O.No.70429/Health I / 2015, dated: 08.01.2016 and ASL No. 1884 (one thousand eight hundred and eighty four).
