ORDER:

The Director of Medical Education in her letter read above, has sent proposal for according administrative and financial sanction for the Operation and Maintenance of Super Specialty Hospital and Trauma Care Centre constructed under Prathan Mandri Swasthaya Surakash Yojana Scheme in the Government Mohan Kumaramangalam Medical College, Salem at a cost of Rs. 41.00 lakhs. He has furnished the estimate for Operation and Maintenance of Super Speciality Hospital and Trauma Care Centre in the Government Mohan Kumaramangalam Medical College, Salem with the following provisions:-

- 1. Operation and Maintenance of Water Treatment Plant.
- 2. Operation and Maintenance of Sewage Treatment Plant.
- 3. Operation and Maintenance of Bore Well.
- 4. Operation and Maintenance of Water Supply Lines.
- 2. The Director of Medical Education has stated that the estimate has been made to operate the above item of works by engaging skilled labours on Non Muster Roll basis splitting the operation period into three shifts per day and with lumpsum provision for the following:-
 - I. Provision for reliever to operate and helpers during leave period.
 - II. Purchase of spares, Sodium chloride for recharging membranes, chlorine, filter media adding membranes and servicing and maintenance of Water Treatment Plant.
 - III. Purchase of spares and servicing and maintenance of Bore Well with pump sets.
 - IV. Renewing G.I pipelines, specials, gate valves, wash basin accessories and flushing tank of EWC's accessories.
- 3. The Director of Medical Education has countersigned and forwarded the Rough Cost Estimate for a sum of Rs.41.00 lakhs (Rupees Forty One Lakhs only) in duplicate prepared by Chief Engineer (Buildings), Trichy Region, Trichy based on the Schedule of rates for the year 2013-2014.

- 4. The Director of Medical Education has requested the Government to sanction a sum of Rs. 41.00 lakhs (Rupees Forty One Lakhs only) for operation and maintenance of Super Speciality Hospital with Trauma Care Centre in the Government Mohan Kumamaramangalam Medical College Hospital, Salem for the year 2013-2014.
- 5. The Government have examined the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs. 41.00 lakhs (Rupees Forty One Lakhs only) for operation and maintenance of Super Speciality Hospital with Trauma Care Centre in the Government Mohan Kumamaramangalam Medical College Hospital, Salem for the year 2013-2014 with a direction to duly follow codal procedures wherever relevant.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account -
