#### ORDER:

The Director of Medical and Rural Health Services, in his letter dated.27.04.2015 has stated that the Tamil Nadu State Illness Assistance Society, Chennai-6 is a Shared Scheme between State and Centre, at the ratio

of 2:1 (2 shares by State Government and One share by Central Government) sanctioning Financial Assistance to Below Poverty Line people, who had undergone Life saving surgeries / treatment. He has also stated that a sum of Rs.5 Crores, have been provided in Budget Estimate 2015 -2016 to the Tamil Nadu State Illness Assistance Society, Chennai-6, being the State Government share under the Head of Account "2210-06-800 UA-09-03 Grants for specific Schemes".

2) The Director of Medical and Rural Health Services has further stated that the fund position of Tamil Nadu State Illness Assistance Society, Chennai-6 is only Rs.4,10,54,793/- (Rupees Four Crore Ten Lakhs Fifty Four Thousand Seven Hundred and Ninety Three only) as indicated below:

The Revolving Fund to the 14 Government Medical College Hospitals and to 32 District Collectors have to be recouped.

3) The Director of Medical and Rural Health Services has stated that after the implementation of Chief Minister's New Comprehensive Health Insurance Scheme, the Below Poverty Line People, whose annual income is Rs.72,000/- and below, and who have been operated by obtaining loans and selling their belongings, are approaching for financial assistance to the Tamil Nadu State Illness Assistance Society, as payments could not be made for the operated cases under Chief Minister's New Comprehensive Health Insurance Scheme. The only option left out to these people, is Tamil Nadu State Illness Assistance Society, which is offering financial assistance to a maximum of Rs.25,000/- for life saving surgeries / treatment to the Below Poverty Line.

4) The Director of Medical and Rural Health Services has further stated that the Revolving Fund have to be recouped as and when the District Collectors and Government Medical College Hospitals send the Utilisation Certificate. The anticipated expenditure by recoupment of Revolving Fund are, follows:-

32 District Collectors	-	Rs.3.95 Crores
14 Government Medical College Hospitals	-	Rs.2.90 Crores
Total	-	Rs.6.85 Crores

5) The Director of Medical and Rural Health Services has also sent the statement of Receipt and Expenditure for the financial year from 01.04.14 to 31.03.15 and requested the Government to accord permission to draw a sum of Rs.5.00 crores provided in Budget Estimate 2015-2016 to credit the same into the PD Account of the Tamil Nadu State Illness Assistance Society, being maintained at State Bank of India, (Treasury Branch), Thousand Lights, Chennai-6.

6) The Government after careful examination, accord sanction a sum of Rs.2.00 Crores (Rupees Two crores only) from the funds available in the Budget Estimate 2015-2016 to the Tamil Nadu State Illness Assistance Society, being the State Government share, so as to credit the same into the PD account of Tamil Nadu State Illness Assistance Society, Chennai-6.

7. The amount sanctioned in para 6 above shall be debited to the following head of account:-
