## **ORDER:**

In the Government Order first read above, orders were issued sanctioning a sum of Rs.72,50,000/- (Rupees Seventy two lakh and fifty thousand only) for starting new Post Graduate Medical Course and Increase of Post Graduate seats in various Government Medical Colleges from the academic year 2020-2021 towards application fees payable to the Medical Council of India, New Delhi and affiliation fees payable to the Tamil Nadu Dr.MGR Medical University, Chennai.

2. The Board of Governors In Supersession of Medical Council of India has issued an amendment notification dated 04.04.2019 for enhancing the existing Post Graduate Teacher: Student ratio. As per the Board of Governors In Supersession of Medical Council of India revised Amendment Notification, the Director of Medical Education has submitted a proposal in his letter second read above for increase of existing Post Graduate seats in the specialities of Geriatric Medicine & General Medicine, as detailed below.

The Director of Medical Education has stated that the Deans of the above said Government Medical Colleges have adequate infrastructure facilities in terms of Faculty and other facilities of Beds, Equipments and clinical material as per MCI norms for these increase.

3. The Director of Medical Education requested to issue necessary permission & Essentiality Certificate, to increase the Post Graduate seats in the specialities detailed above.

4. The Government have examined the proposal of the Director of Medical Education and decided to accept the same. Accordingly, the Government hereby grant permission to the Director of Medical Education to increase the number of Post Graduate seats in the Government Medical Colleges as tabulated below and permit him to incur an expenditure of Rs.9,56,000 (Rupees Nine lakhs and fifty six thousand only) at the rate of Rs.2.36 lakhs per course, towards application fees payable to the Medical Council of India, New Delhi and Rs.2.42 lakhs per course towards affiliation fees, payable to the Tamil Nadu Dr.MGR Medical University, Chennai, from the Personal Deposit Account of the Director of Medical Education, being maintained by the Secretary, Selection Committee.
