ORDER:

The District Collector, Krishnagiri in his letter first read above has stated that Krishnagiri District started functioning from 09.02.2004 and requested the Government to create one post of District Extension Educator to Krishnagiri District to implement the activities of Family Welfare Programme at Krishnagiri District.

2. The Director of Family Welfare has stated that Government of India has not given its concurrence for the creation of the post of District Extension Educator in the newly formed Districts. The Government of India had also stated that the expenditure arising out of the creation of such new posts, shall not be reimbursed to the State Government and State Government only has to meet the expenditure. In order to curtail the additional expenditure to State Government and in order to carryout the Family Welfare Programme effectively in the office of the District Collector, Krishnagiri, the Director of Family Welfare has proposed and recommended that one post of District Extension Educator attached to the District Family Welfare Bureau, Dharmapuri District may be redeployed to the District Collector's Office, Krishnagiri and the Block Extension Educator Dharmapuri District may be requested to carry out the functions of the District Extension Educator of Dharmapuri District. The Director of Family Welfare has

therefore requested the Government to sanction one post of District Extension Educator to the Collectorate of Krishnagiri for co-ordinating the family welfare activities by redeploying the existing post of District Extension Educator in District Family Welfare Bureau of Dharmapuri District.

3. After careful consideration of the proposal of the Director of Family Welfare, the Government have decided to sanction one post of District Extension Educator to the Collectorate of Krishnagiri District by redeploying the existing post of District Extension Educator in District Family Welfare Bureau, Dharmapuri District as shown in the annexure to this order, subject to the condition that no proposal for the creation of post of District Extension Educator in Dharmapuri District will be entertained in future.

4. This Order issues with the concurrence of Finance Department vide its U.O.No.37930/H-I/2014, dated 15.07.2014.


