### **ORDER:**

The Mission Director, National Health Mission has reported that a proposal with a total budgetary requirement of Rs.1359.10 lakh for construction of Hostel Buildings in Government Hospital Tirupur and Government Medical College, Tirunelveli has been included in PIP 2013-14 which was approved by the National Programme Co-ordination Committee (NPCC), Government of India with an initial provision of Rs.407.73 lakh at 30% of total requirement of Rs.1359.10 lakh for Civil works for the year 2013-14 and the Executive Committee approved the same in its 24<sup>th</sup> meeting held on 08.10.2014. The amount released by the Government of India was remitted into Government of Tamil Nadu account, under receipt head of account and sanctioned to Public Works Department vide the G.O first read above.

2. The Mission Director, State Health Society has added that the fund amounting a sum of Rs.951.37 lakh, at 70% of total requirement of Rs.1359.10 lakh for above said works, has been approved for the year 2014-15, in the Supplementary

Programme Implementation Plan (PIP) 2014-15 and the same amount has been remitted in to Government of Tamil Nadu account, under receipt head of account vide Challan No.210, dated: 28.03.2015 of State Bank of India, Treasury Branch, Thousand Light, Chennai.

3. The Mission Director, State Health Society has therefore, requested the Government ;

- I. to sanction a sum of Rs. 951.37 lakh (Rupees Nine crore fifty one lakh and thirty seven thousand only) to Public Works Department which already been remitted into the State Government Account for execution of approved civil works for construction of Hostel Buildings in Government Hospital, Tiruppur and Government Medical college, Tirunelveli in addition to the amount of Rs.407.73 lakh already sanctioned in G.O 1<sup>st</sup> read above.
- II. to permit the Engineer in Chief (Buildings), Public Works Department to issue orders to the Executive Engineers of the concerned divisions for carrying out the above work

4. The Mission Director, State Health Society has further requested that the drawal of funds may be allowed in BE 2015-16 as the funds have already been remitted in to Government account

5. The Government, after careful examination, accept the proposal of Mission Director, State Health Society and accordingly, orders as follows:-

- (i) sanction is accorded for a sum of Rs. 951.37 lakh (Rupees Nine crore fifty one lakh and thirty seven thousand only) to the Engineer in Chief and Chief Engineer (Buildings) for execution of civil works required for construction of Hostel Buildings in Government Hospital Tiruppur and Government Medical college, Tirunelveli by availing funds already remitted into the State Government Account in addition to the funds of Rs. 407.73 lakh sanctioned in G.O (Ms).No.273, Health and Family Welfare Department, dated 25.11.2013
- (ii) the Engineer in Chief ( Buildings), Public Works Department is permitted to issue orders to the Executive Engineers of the concerned divisions for carrying out the Civil Works required for construction of Hostel Buildings in Government Hospital, Tiruppur and Government Medical college, Tirunelveli

6. The expenditure sanctioned in para 5 above shall be debited to the following Head of account:-

“ 4211-00-Capital outlay on Family Welfare -103 Maternity and Child Health – Schemes in the Twelfth Five Year Plan – III Centrally Sponsored – SA – National Component – Reproductive and Child Health Project – 16 Major works”. (DPC 4211-00-103-SA-1608)
