## ORDER:

In the G.O. first read above, the Government have sanctioned five posts of Microbiologist to the Food Analysis Laboratories under Food Safety and Drug Administration Department. In the G.O. second read above, the Government have appointed two candidates selected through Tamil Nadu Public Service Commission as Microbiologist in Food Safety and Drug Administration Department and posted at Coimbatore and Madurai Food Analysis Laboratory. The remaining three Food Analysis Laboratories i.e. Palayamkottai, Thanjavur and Salem are now functioning without Microbiologist.

2. In the letter third read above, the Commissioner, Food safety and Drugs Administration Department has stated that as per rule 2.4.25 of FSS Rules 2011, the Food Analyst should issue the analysis report within fourteen days of the receipt of the sample lifted under FSS Act. It is not possible to test all the samples, which required microbiological analysis only at three Food Analysis Laboratories where the post of

Microbiologists working. Therefore, the Commissioner, Food Safety and Drugs Administration Department has requested the Government to address the Tamil Nadu Public Service Commission to release three candidates from the reserve list, so as to appointment them at Food Analysis Laboratories, Palayamkottai, Thanjavur and Salem.

- 3. In the letter fourth read above, the Tamil Nadu Public Service Commission has released the name of three candidates from the reserve list, for appointment to the post of Microbiologist temporarily with the condition that the candidates now sponsored should be appointed as per the conditions specified in rule 10(a) (i) of the General Rules for the Tamil Nadu State and Subordinate Services.
- 4. Accordingly, the Government appoint the following three candidates released by Tamil Nadu Public Service Commission from the reserve list, as Microbiologist temporarily in the Department of Food safety and Drug Administration as per rule 10 (a) (i) of General Rule for Tamil Nadu State and Subordinate Service Rules, subject to the condition that they shall be replaced as soon as possible by a member of service or an approved candidates qualified to hold the post under the rules and in any case, shall not be continued for a period of more than one year from the date his / her temporary appointment, as stipulated in Rule 10 (a) (iii) of the General Rules for Tamil Nadu State and Subordinate Services.
