### **ORDER:**

The Mission Director, State Health Society has reported that the proposal for construction of new buildings for 60 Primary Health Centres in the State ( 11 Primary Health Centres in High Priority Districts and 49 Primary Health Centres in other Districts) for upgrading them as 30 bedded Primary Health Centres under National Rural Health Mission at a cost of Rs.87.00 lakh each had been included in 1st supplementary PIP 2013-14 and the same has been approved by the National Programme Co-ordination Committee (NPCC) of Government of India with an initial provision of Rs.1566.00 lakh for the year 2013-14 at 30% of the total cost.

2. As per orders issued in G.O(MS)No.116, Health and Family Welfare (EAP II-2) Department, Dated: 25.03.2011, the Mission Director, State Health Society has remitted the sum of Rs.1566.00 lakh received from Government of India for the approved civil works for the year 2013-14 into Govt. account under receipt head, vide challan No.1073, Dt.08.01.2015 of State Bank of India treasury Branch , Thousand light, Chennai for execution of the civil works, through Public Works Department.

3. The Mission Director, State Health Society has also reported that due to the revision of schedule of rates and inclusion of certain additional works required for

overall improvement to the buildings, the cost of construction in respect of UGPHCs was revised from Rs. 87.00 lakh to Rs. 105.00 lakh each and the proposal included in the 2<sup>nd</sup> Supplementary PIP 2013-14, approved by the National Programme Co-ordination Committee (NPCC) of Government of India and the same approved in the 26<sup>th</sup> Executive Committee Meeting held on 4.02.2014 vide agenda No.19

4. The Mission Director, State Health Society has added that in G.O (Ms).No.52, Health and Family Welfare( EAP II-2) Department, dated: 21.02.2014, among the other things, it was ordered for upgrading total No. of 64 Primary Health Centres in which 63 were under National Rural Health Mission and one was under State Fund out of 63 Primary Health Centres have been included in the Programme Implementation Plan (PIP), 2013-2014 and 2014-2015

5. Further, the Mission Director, State Health Society has reported that the National Programme Co-ordination Committee (NPCC) of Government of India approved the balance fund of Rs.4734.00 lakh ( Rupees Four thousand seven hundred and thirty four lakh only), ( 70% of balance funds of Rs.3654 lakh + Rs.1080 lakh i.e., escalation cost of Rs.18.00 lakh X 60 Primary Health Centres ) for civil works for the year 2014-15, and the same has been remitted into Government account, under receipt head of account vide challan No.918, dated: 05.02.2015 of State Bank of India, Treasury Branch Thousand light, Chennai.

6. The Mission Director, State Health Society has, therefore, requested the Government orders for the following,-

- I. to revise the cost of construction of buildings from 87.00 lakh to Rs. 105.00 lakh per Primary Health Centres as per the approval of Government of India,
- II. to sanction of Rs. 6300/- lakh to Engineer in Chief and Chief Engineer (buildings) for execution of civil works at the rate of Rs. 105.00 lakh each for Upgradation of 60 Primary Health Centres listed in the annexure to this order; and
- III. to permit the Engineer in Chief and Chief Engineer (Buildings), Public Works Department to issue orders to the Executive Engineers of the concerned divisions for carrying out the civil works.

7. The Government after careful examination have decided to accept the proposal of the Mission Director, State Health Society and they order ,-

(i) permitting the Mission Director, State Health Society to revise the cost of construction of buildings from 87.00 lakh to Rs. 105.00 lakh per Primary Health Centres as per the approval of Government of India.

(ii) sanctioning a sum of Rs.6300 lakh (Rupees Six thousand three hundred lakh only) approved for the year 2013-14 & 2014-15 for execution of civil works relating to the construction of 60 Upgraded Primary Health Centre at the revised rate of Rs.105 lakh ( Rupees Hundred and five lakh only), listed in the annexure to this order.

(iii) The Engineering and Chief Engineer (Buildings) Public Works Department is permitted to issue orders to Executive Engineers of the concerned Divisions for carrying out the Civil works required for construction of buildings for 60 UGPHCs, listed in annexure to this order.

8. The expenditure sanctioned in para 7 above shall be debited to the following Head of account:-

“ 4211-00-Capital Outlay on Family Welfare -103 Maternity and Child Health – Schemes in the Twelfth Five Year Plan – III Centrally Sponsored – SA – National Component – Reproductive and Child Health Project – 16 Major works”. (DPC 4211-00-103-SA-1608)
