ORDER:

The Managing Trustee, Royal Educational Trust, Madukkarai, Coimbatore District has requested the Government to grant permission to start two years Diploma in Medical Laboratory Technology course in the name and style as “Royal College of Pharmacy and Paramedical Sciences, Navakkarai, Madukkarai, Coimbatore District” with an annual intake of 15 students from the academic year 2018-2019.

2. In its Government letter first read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Pharmacy College has fulfilled the conditions prescribed by the Government norms.

3. In his letter second read above, the Director of Medical Education has sent the proposal in which he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government Guidelines. Hence, the Director of Medical Education has recommended to give permission to the Managing Trustee, Royal Educational Trust, Madukkarai, Coimbatore District to start two years Diploma in Medical Laboratory Technology course in the name and style as “Royal College of Pharmacy and Paramedical Sciences, Navakkarai, Madukkarai, Coimbatore District” with an annual intake of 15 students from the academic year 2019-2020.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Managing Trustee, Royal Educational Trust, Madukkarai, Coimbatore District to start 2 years Diploma in Medical Laboratory Technology course with an annual intake of 15 (fifteen) students in the name and style as "Royal College of Pharmacy and Paramedical Sciences in S.F.No. 138/2A, Navakkarai, Madukkarai, Coimbatore District" from the academic year 2019-2020. Accordingly, the Government do and hereby direct that the Managing Trustee, Royal Educational Trust, Madukkarai, Coimbatore District permitted to start 2 years Diploma in Medical Laboratory Technology course with an annual intake of 15 students in the name and style as "Royal College of Pharmacy and Paramedical Sciences in S.F.No. 138/2A, Navakkarai, Madukkarai, Coimbatore District" from the academic year 2019-2020, subject to the following conditions:-

- i. the Trust should construct 75 bedded own hospital within a period of 3 years.
- ii. the Trust should obtain building plan approval from the Directorate of Town and Country Planning.
- iii. the Trust should obtain the building completion certificate from the competent authority.
- iv. the Trust should obtain Clearance Certificate from State Pollution Control Board for the proposed Paramedical Institution before admitting the students.

5. The Director of Medical Education is directed to take necessary further action accordingly.
