ORDER:

The Managing Trustee, G.T. Narayanasamy Naidu Charities Trust, Dindigul has requested the Government to grant permission to start four years B.Sc Nursing course in the name and style as “GTN College of Nursing, Dindigul” with an annual intake of 60 students from the academic year 2019-2020.

2. In its Government letter sixth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to five read above and the Indian Nursing Council, New Delhi.

3. In his letter seventh read above, the Director of Medical Education has submitted the proposal in which he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to give permission to the Managing Trustee, G.T. Narayanasamy Naidu Charities Trust, Dindigul to start four years B.Sc Nursing course in the name and style as "GTN College of Nursing, Dindigul" with an annual intake of 60 students from the academic year 2019-2020.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Managing Trustee, G.T. Narayanasamy Naidu Charities Trust, Dindigul to start four years B.Sc Nursing course with an annual intake of 60 (sixty) students in the name and style as "GTN College of Nursing in S.F. No.205/1B2pt, 203/1pt, 2pt, 199/2pt, 200/1pt, 200/2bpt, 200/3bpt, Old Karur Road, Seelapadi Village and Panchayat, Dindigul West Taluk, Dindigul District from the academic year 2019-2020. Accordingly, the Government do and hereby direct that the Managing Trustee, G.T. Narayanasamy Naidu Charities Trust, Dindigul permitted to start four years B.Sc Nursing course with an annual intake of 60 students in the name and style as "GTN College of Nursing in S.F. No.205/1B2pt, 203/1pt, 2pt, 199/2pt, 200/1pt, 200/2bpt, 200/3bpt, Old Karur Road, Seelapadi Village and Panchayat, Dindigul West Taluk, Dindigul District from the academic year 2019-2020, subject to the following conditions:-

- a) Admission of students shall be made as per the rules fixed by the Government from time to time.
- b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Nursing Colleges.
- c) The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, and Tamil Nadu Dr. M.G.R. Medical University and suitability of Indian Nursing Council, New Delhi, if needed, respectively before admitting the students.
- d) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons etc.

- e) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- f) The Trust should not run any other Nursing institution within 10 kms radius.
- g) The Trust should construct 150 bedded own hospital within a period of 3 years.
- h) The Trust should provide separate vehicles for GTN College of Nursing.
- i) The Trust should obtain the building completion certificate from the competent authority and building plan approval from the Directorate of Town and Country Planning (DTCP) for the proposed Nursing College and submit to the Government before admitting the students.

4. The Director of Medical Education is directed to take necessary further action accordingly.
