(5) Full justification for instituting the MS General Surgery course:

On careful consideration of the proposal, the Government of Tamil Nadu has decided to issue an essentiality certificate to the applicant for the Starting of MS General Surgery with annual intake of 08 seats per year at Government Erode Medical College and Hospital at Perundurai, Erode District from the academic year 2021-2022, subject to the condition that the approval of Medical Council of India / Government of India should be obtained before the students are admitted.
