## ORDER:-

In the Government Order first read above, 25 posts of Data Entry Operator on consolidated pay of Rs. 2500/- per month under Part II Scheme (2005-2006) were sanctioned, temporarily for a period of one year from the date of filling up or till the need ceases to strengthen the SBHI at district level and the Director of Public Health and Preventive Medicine was permitted to fill up the post through Employment Exchange by strictly following communal rotation. Among the Data Entry Operator's joined duty, 7 are differently able persons and continuously working for more than two years.

- 2. In the G.O. Second read above, orders were issued to the effect that the services of the disabled persons working in Government Department on consolidated pay for more than two years may be brought under time scale of pay by the respective Heads of Departments and their services may be regularized by relaxation of rules if any after getting approval of the Government.
- 3. The Director of Public Health and Preventive Medicine in his letter third read above requested the Government to regularize the services of the 7 disabled persons working as Data Entry Operators and to bring them under the time scale of pay of Rs.5200-20200+GP 2400.
