ORDER:

In the Government Order first and second read above, the Government have re-designated one post of Professor of Pharmacy in Madras Medical College, Chennai and one post of Professor of Pharmacy in Madurai Medical College, Madurai as 'Principal' in the scale of pay of Rs. 15600-39100 + G.P.7700.

2. In the reference third read above, the Director of Medical Education has sent proposal for issuing an amendment to the Special Rules for the Tamil Nadu Medical Service for the post of Principal, College of Pharmacy and has requested the Government for approving the same.

3. In the Government Order fourth read above, based on the norms of AICTE, the Government have amended the Special Rules for the Tamil Nadu Medical Service with regard to changing the nomenclature for the teaching faculties of College of Pharmacy and as per the amended rule, the nomenclature of the post of Reader in Pharmacy, Assistant Reader in Pharmacy and Tutor in Pharmacy as Professor, Associate Professor and Assistant Professor and the qualifications for the teaching faculties have also been enhanced as per the norms of AICTE.

4. In their letter sixth read above, the Tamil Nadu Public Service Commission has given their concurrence in this regard.

5. The Government have examined the proposal of the Director of Medical Education in detail along with the views of the Tamil Nadu Public Service Commission. The Government accordingly do and hereby direct that the following amendments to the Special Rules for the post of Principal, College of Pharmacy in the Tamil Nadu Medical Services be issued.

6. Accordingly, the appended Notification will be published in the Tamil Nadu Government Gazette.

APPENDIX.**NOTIFICATION.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Medical Service (Section 21 in Volume-II of the Tamil Nadu Services Manual, 2016).

2. The amendments hereby made shall be deemed to have come into force on and from the 22nd August 2007.

AMENDMENTS.

In the said Rules, in Part II, under the heading "Branch – I Medical", -

(1) in rule 1, under Class V, -

- (a) for the expression "Category 1", the expression "Category 1A" shall be substituted.
- (b) before the entries "Category 1 A" as so substituted, the following entries shall be inserted, namely:-
"Category 1- Principal, College of Pharmacy.";

(2) in rule 3, in sub-rule (a), in the tabular column, under Class V, -

- (a) for the expression "Category 1", the expression "Category 1-A" shall be substituted.
- (b) before the expression "Category 1 A" in column (1) as so substituted and the entries relating thereto in column (2), the following entries shall, respectively, be inserted, namely:-

"Category 1 -	1. Promotion from the post of Professor in any branch of Specialization in Pharmacy; or
	2. by direct recruitment, if no qualified candidates are available in the above method.

(3) in rule 7, in sub-rule (a), in the table, after the entries "Research Assistant to the Chemical Examiner" in column (1) and the corresponding entries in column (2) thereof, the following entries shall, respectively be, inserted, namely:-

"Principal, College of Pharmacy 45 years";

(4) in rule 9, in sub-rule (b), in clause (ii), after the seventh proviso, the following proviso shall be added, namely:-

"Provided also that a person appointed by promotion to the post of Principal, College of Pharmacy, need not undergo probation.";

(5) in rule 13, in sub-rule (a), after the entries "Research Assistant to the Chemical Examiner", the following entries shall be inserted, namely:-

"Principal, College of Pharmacy.";

(6) in the Annexure [referred to in rule 8(c)], under Class V, -

- (a) for the expression "Category 1", the expression "Category 1A" shall be substituted
- (b) before the expression "Category 1 A" in column (1) as so substituted and the entries relating thereto in column (2), the following entries shall, respectively be, inserted, namely:-

Category 1
Principal, College of
Pharmacy

1. by Promotion:-

- (a) Must have obtained Ph.D., degree (with First class degree either in B.Pharm or M.Pharm); and
- (b) Must have acquired experience for a period of not less than ten years in the field of teaching, out of which not less than 3 years shall be at the level of Professor or

Minimum of 13 years of teaching experience in the category of Lecturer or Assistant Professor or Associate Professor or Professor

2. by direct recruitment:-

- (a) Must have obtained Ph.D., degree (with First class degree either in B.Pharm or M.Pharm); and
- (b) Must have acquired experience teaching or research or industry for a period of not less than ten years in the field of Pharmacy."
