#### ORDER:-

Based on the Announcement made by the Hon'ble Minister (Health) for the year 2014-2015, the Director of Medical and Rural Health Services has submitted that the Directorate is entrusted with the responsibility of providing secondary level medical care to the public in 30 District Head Quarters Hospital, 160 Taluk and 80 Non Taluk Hospitals through out the Urban, Semi Urban and Rural landscape of the State.

2. The Director of Medical and Rural Health Services has stated that based on the performance of the hospitals for the past years, conversion of Primary Health Centre as Government Hospitals and the bad odors emanating from the dead bodies, the provision of Mortuary Block is absolutely necessary for 10 Government Hospitals.

3. The Director of Medical and Rural Health Services has therefore requested for construction of mortuary block with cold storage at a cost of Rs.3,50,00,000/- (Rupees Three Crores and Fifty Lakhs only) for the following ten Government Hospitals [(i.e) Rs.35 Lakhs for each hospital:

- I. Government Hospital, Edappady, Salem District.
- II. Government Hospital, Sendamangalam, Namakkal District.
- III. Government Hospital, Illupur, Pudukkottai District.
- IV. Government Hospital, Annavasal, Pudukkottai District
- V. Government Hospital, Thuvakudi, Trichy District.
- VI. Government Hospital, Orathanadu, Thanjavur District.

- VII. Government Hospital, Manamelgudi, Pudukkottai District.
- VIII. Government Hospital, Nanguneri, Tirunelveli District.
- IX. Government Hospital, Avadi, Thiruvallur District.
- X. Government Hospital, Vaniyambadi, Vellore District.

4. The Government have examined the proposal of the Director of Medical and Rural Health Services in detailed and accord sanction for construction of Mortuary Block at a total cost of Rs.3,50,00,000/- (Rupees Three Crores and Fifty Lakhs only) i.e. cost of Rs.35.00 Lakhs for each one hospital to the following Government Hospitals:-

- I. Government Hospital, Edappady, Salem District.
- II. Government Hospital, Sendamangalam, Namakkal District.
- III. Government Hospital, Illupur, Pudukkottai District.
- IV. Government Hospital, Annavasal, Pudukkottai District
- V. Government Hospital, Thuvakudi, Trichy District.
- VI. Government Hospital, Orathanadu, Thanjavur District.
- VII. Government Hospital, Manamelgudi, Pudukkottai District.
- VIII. Government Hospital, Nanguneri, Tirunelveli District.
- IX. Government Hospital, Avadi, Thiruvallur District.
- X. Government Hospital, Vaniyambadi, Vellore District.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of the account.

4210 Capital outlay on Medical and Public Health – 01 Urban Health Services – 110 Hospitals and Dispensaries (including Pharmacy) – Schemes in the Twelfth Five Year Plan – II State Plan – JA Buildings – 16 Major works.

6. The Chief Engineer (Buildings), Public Works Department, Chennai-5 is authorized to draw and disburse the amount sanctioned in the para 4 above

7. The expenditure sanctioned in para 4 above, shall constitute an item of " New Instrument of Service" and the approval of legislature will be obtained in due course pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings) is directed to calculate the actual amount required for the period upto next Supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. The Chief Engineer (Building) Shall apply for sanction of advance from contingency fund for the required amount in the prescribed format along with a copy of this order of Finance (BG-I)

Department. The Chief Engineer (Building) shall also send necessary explanatory notes to include the above expenditure in the supplementary estimate for the year 2015-2016 to Finance Department at the appropriate time without fail.

8. This order issues with the concurrence of Finance Department vide its U.O. No. 126/ADS (Dr.Pu)/Health-II/2014, dated 29.07.2015 and Additional sanction ledger No. 664 (Six Hundred and Sixty Four).
