### **ORDER:**

The Director of Medical Education has stated that the Institute of Neurology has been functioning since 1960 and the Department of Neurology has grown up to the level of hospital, which requires separate Institute for both Neuro Surgery and Neuro-medical, so that the research and patient care will improve more. She has requested necessary orders for bi-furcating the department as Institute of Neuro Surgery with a senior most Professor as Head of Department and the Head of the Department will be re-designated as Director and Professor in both the Departments.

- 2. She has justified that the Medical Officers working as Head of Department in the above said department have already reached maximum scale of pay. Hence there will be a very meager additional expenditure to the Government. The Dean has also certified that there will be no extra expenditure involved to the Government in the proposal for converting the department as Institute. Moreover all the other expenditure will be met out from the Chief Minister's Comprehensive Health Insurance Scheme. (CMCHIS)
- 3. The total recurring expenditure for upgrading two posts of Professor into Director is approximately Rs.4800/- i.e Rs.2400/- each. If it is upgraded, the department can improve by utilizing the services of experts and train the technicians with international standard.
- 4. The Government have examined the proposal of Director of Medical Education and accord sanction for the Upgradation of the Department of Neurology at Madras Medical College/ Rajiv Gandhi Government General Hospital, Chennai as "Institute of Neurology" and upgradation of one post of Professor (Rs.37400-67000+GP 8700/-) in the Department of Neurology into that of Director of Neurology in the scale of pay of Rs.37400-67000 + Grade Pay 8800/-.

- 5. The expenditure towards pay and allowances for the post shall be debited to the following Head of Account:-
