The corresponding 40% of the State share against the 60% of the Government of India share of Rs. 62,00,000/- (Rupees Sixty two lakh only) works out of Rs.41,33,333/- (Rupees Forty one lakh thirty three thousand and three hundred and thirty three only).

The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.1,03,33,333/- (Rupees One crore three lakh thirty three thousand and three hundred and thirty three only) being the State and Central Share contribution of Grants-in-Aid for Other Health System covered under National Urban Health Mission during the year 2018-19 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into National Health Mission Account.
- 3. The Government after careful consideration has decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.1,03,33,333/-(Rupees One crore three lakh thirty three thousand and three hundred and thirty three only) being

the State and Central Share contribution of Grants-in-Aid for Other Health System covered under National Urban Health Mission for the year 2018 – 2019.
