ORDER:-

In the Government order first read above, the Government have issued orders for upgradation of the Department of Surgical Gastroentrology at Government Stanley Medical College, Chennai as "Institute of Surgical Gastroentrology and Liver Transplant".

- 2. The Professor and Head of the Department, Institute of Surgical Gastroenterology and Liver Transplantation, Government Stanley Medical College, Chennai has stated that the institute is a tertiary referral centre for patients from other parts of Tamil Nadu and also from neighbouring States. This is the first ever department in a Government sector to get ISO 9001:2000 accreditation in the entire state. M.Ch super speciality course in Surgical Gastroenterology was started in the department in 2002. A Liver Transplant unit was sanctioned to the department, first of its kind in the Government sector in the country.
- 3. The Director of Medical Education has stated that by upgrading the Department of Surgical Gastroenterology into an Institute, it will elevate the status of the College to national standards and by promoting the post of Professor into Director, it will not affect the MCI norms. The Director has shown as Professor for all academic activities regarding the MCI norms. The Director will have overall department control of the department and he will be able to establish research activities and raise standards to National levels

which will invite funding agencies to invest in this institute bringing in better scope and avenues in the field of Surgical Gastroenterology.

- 4. The Director of Medical Education has therefore requested the Government to upgrade one post of Professor as Director to provide better treatment to poor patients coming to the Government Hospital.
- 5. The Government have examined the proposal carefully and accord sanction to upgrade one post of Professor and Head of the Department, Institute of Surgical Gastroenterology and Liver Transplantation as Director of Institute of Surgical Gastroenterology and Liver Transplantation, Government Stanley Medical College, Chennai in the scale of pay of Rs. Rs. 37400-67000 with Grade Pay of Rs.8800/-.
- 6. The expenditure towards pay and allowances for the post shall be debited to the following Head of Account:-
