ORDER :

The Director of Medical Education in his letter sixth read above stated that in G.O.(Ms.) No.301, Health and Family Welfare (E2) Department, Dated 19.12.2016, the Government have accorded sanction of various posts including four posts of Laboratory Attendant to Centre of Excellence, Institute of Diabetology, Government Stanley Medical College, Chennai in the scale of pay of Rs.4800–10000 + Grade Pay Rs.1300/- as per the pre-revised scale.

2. The Director of Medical Education has further stated that as there is no specific rule to fill-up the post of Laboratory Attendant in Tamil Nadu Basic Services, the Dean, Government Stanley Medical College, Chennai has requested for amendment in G.O.(Ms.) No.301, Health and Family Welfare (E2) Department, Dated 19.12.2016 with regard to the said post of Laboratory Attendant and the Dean has stated that in Tamil Nadu Basic Services Rule-Class III - Category 4, the post of Attendant has been mentioned which also carries the same scale of pay with the same duties and responsibilities as vested with the cadre of Laboratory Attendant.

3. The Director of Medical Education has, therefore, requested the Government to issue suitable amendment order for the post of Laboratory Attendant into "Attendant" sanctioned to Government Stanley Hospital, Chennai, as the posts of Laboratory Attendant and Attendant carry the same scale of pay, same qualification and job responsibilities and the head of institution is the appointing authority for the said post.

The Government have examined the proposal of the Director of Medical Education in detail and found that the post of Lab Attendant / Laboratory Attendant / Laboratory Attendant Grade-II sanctioned to Thoothukudi Government Medical College, Thoothukudi, Government Medical College and Hospital, Pudukottai, Government Stanley Hospital, Chennai, Government Mohan Kumaramangalam Medical College and Hospital, Salem, Government Karur Medical College and Hospital, Karur in the Government Orders first to sixth read above. Hence, the Government have decided to amend the nomenclature for the post of Lab Attendant into that of "Attendant" to the above said institutions. The Government accordingly do and hereby direct that the post of Lab Attendant / Laboratory Attendant / Laboratory Attendant Grade – II sanctioned to Thoothukudi Government Medical College, Thoothukudi, Government Medical College and Hospital, Pudukottai, Government Stanley Hospital, Chennai, Government Mohan Kumaramangalam Medical College and Hospital, Salem, Government Karur Medical College and Hospital, Karur under the control of Directorate of Medical Education in the Government Orders first to sixth read above be amended as follows:-

AMENDMENT

"the nomenclature of the post of 'Lab Attendant / Laboratory Attendant / Laboratory Attendant Grade-II', wherever occurs in Government Orders first to sixth read above, the following nomenclature shall be substituted "Attendant".


