ORDER:

In the G.O. first read above among other things, the Government have accorded administrative sanction for the work of "Construction of CEMONC building in Government Chengalpattu Medical College Hospital, Chengalpattu" at Rs.1050.00 lakhs and the work is under progress. The Assistant Executive Engineer, Public Works Department has therefore requested the Government to issue administrative and financial sanction for a sum of Rs.94.85 lakhs for remaining works for strengthening of HT supply with 2 Nos. 500 KVA Transformers for praviding power supply in newly constructed CEMONC Building in Chengalpattu Medical Callege Hospital, Chengalpattu.

- 5. After detailed examination, the Government have decided to sanction an administrative and financial sanction for a sum of Rs.94,85,000/- (Rupees Ninety Four lakh and eighty five thousand only) for strengthening of HT supply with 2 Nos.
 500 KVA Transformers for providing power supply in newly constructed CEMONC Building in Chengalpattu Medical College Hospital, Chengalpattu.
