#### ORDER:

In the Government Order first read above orders have been issued sanctioning 83 Medical and 232 Non-Medical posts for the Tamil Nadu Government Multi Super Speciality Hospital, Chennai.

2. In the Government order second read above the remuneration for the 83 posts of Medical Officers on contract basis has been fixed as follows:-

It was also ordered that in respect of Medical Officers appointed in the above posts on deputation basis i.e., those who are already in Central / State Government/ Local bodies / Public Sector Undertakings, the pay and allowances will be the same as they are otherwise eligible under the original service to which they belong. HRA, CCA, Travel Allowances, etc., will be as per the rules in force.

3. The Director of Medical Education has stated that out of the 83 posts of Medical Officers, 55 posts have been filled with 'in-service' doctors on deputation from Tamil Nadu Government Medical Service. Currently their services are utilized in the Tamil Nadu Government Multi Super Speciality Hospital while their salaries are continued to be drawn in their original place of posting. Consequently, their original places of posting cannot be filled. Some of the institutions have requested to transfer them to Tamil Nadu Government Multi Super Speciality Hospital, so that the above posts can be filled up.

4. Hence, the Director of Medical Education has requested the Government to issue the following:

83 posts of medical personnel sanctioned may be permitted to be filled up by personnel recruited and working in Government in the Tamil Nadu Medical Service in the time scales of pay as detailed below:

Wherever there are inadequate doctors in a super speciality, such posts may be filled up through contract appointment. Whenever the in-service candidates are transferred and posted to Tamil Nadu Government Multi Super Speciality Hospital, Chennai they may be filled up in the time scale of pay / cadre and in case private candidates are appointed, it may be done on contract basis.

5. The Director of Medical Education has further stated that due to the modification, there will not be any additional expenditure to the Government.

6. The Government have examined the above proposal carefully and to issue the following orders in continuation of the Government Orders first and second read above,

- i. the 83 posts of Medical Officers sanctioned in the Government order first cited be filled up by personnel recruited and working in Government in the Tamil Nadu Medical Service by transfer; Wherever there are inadequate doctors in a Super Speciality, such posts be filled up through contract appointment on the consolidated salary as fixed in the Government Order second read above.
- ii. The salary in respect of Medical Officers who are so posted in the Tamil Nadu Government Multi Super Speciality Hospital, be fixed in the time scales of pay as detailed below:
