ORDER:

The Mission Director, National Health Mission in his letter read above has stated that, the Government of India have sanctioned grants for National Health Mission in ROP 2019-20. The ROP for 2019-20 had been placed in 35th EC and got approved. Further, the Government of India have released Grants-in-Aid for Ayushman Bharat-Health & Wellness Centre under National Rural Health Mission programme during 2019-20 and credited into State Government Account as detailed below:-

The corresponding 40% of the State Share against the 60% of the Government of India release of Rs.23,66,00,000/- (Rupees Twenty three crore and sixty six lakh Only) works out of Rs.15,77,33,333/- (Rupees Fifteen crore seventy seven lakh thirty three thousand three hundred and thirty three only).

2. Finally, the Mission Director has requested the Government to issue orders for the drawal of Rs.39,43,33,333/- (Rupees Thirty nine crore forty three lakh thirty three thousand three hundred and thirty three only) towards Central and State Share of the Ayushman Bharat-Health & Wellness Centre under National Rural Health Mission Programme, since, the Government of India have transferred the Grants-in-Aid to State Government for drawal of amount through Treasury. The Mission Director, National Health Mission has also requested to authorize him to draw the above amount through Treasury mode and credit into National Health Mission Account.

3. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly:-

- (i) Sanction is accorded for a sum of Rs.39,43,33,333/- (Rupees Thirty nine crore forty three lakh thirty three thousand three hundred and thirty three only) towards Central and State Share of the Ayushman Bharat-Health & Wellness Centre under National Rural Health Mission Programme
- (ii) The Mission Director, National Health Mission is permitted to authorize to draw the above amount through Treasury mode and credit it into National Health Mission Account.
