ORDER:

The Mission Director, State Health Society in his letter read above has stated that the Central funds under the Centrally sponsored Schemes like National Health Mission are routed through the Treasury route-as part of the State plan and requested to provide for Central Share of National Health Mission in the State Budget. The Government of India in their letter first read above have transferred and credited a sum of Rs.18,00,55,000/- (Rupees Eighteen Crore and fifty five thousand only) into State Government account as their 75% share of Grants in Aid for Flexible pool for communicable Diseases to Tamil Nadu State under Revised National TB Control Programme during the year 2015-16 as mentioned below:-

The Government of India has requested to ensure 25% State contribution based on the release of funds by Government of India.

2. The Mission Director, State Health Society has further stated that the corresponding 25% of the State Share against the 75% of the Government of India release of Rs.18,00,55,000/- (Rupees Eighteen Crore and fifty five thousand only) works out to Rs.6,00,18,334/- (Rupees Six Crore eighteen thousand three hundred and thirty four only). Since Government of India have transferred the grants to State Government for drawal of amount through Treasury route from 2015-16, the amount of Central Share and State Share will have to be drawn from State Budget. He has requested the Government to issue orders to release a sum of Rs. 24,00,73,334/- (Rupees Twenty four crore seventy three thousand three hundred and thirty four only) towards release of Central and State contribution of Grants in aid to the State Health Society under Revised National TB Control Programme for the year 2015-16 and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu to draw a sum of Rs. 24,00,73,334/- (Rupees Twenty four crore seventy three thousand three hundred and thirty four only) under National Health Mission through Treasury mode.

3. The Government after careful consideration have decided to accept the above proposals of the Mission Director, State Health Society and accordingly sanction a sum of Rs. 24,00,73,334/- (Rupees Twenty four crore seventy three thousand three hundred and thirty four only) i.e., Rs.18,00,55,000/- (Rupees Eighteen crore and fifty five thousand only) being 75% of the Government of India Grants-in-aid and Rs.6,00,18,334/- (Rupees Six crore eighteen thousand three hundred and thirty four only) being 25% of the State share as matching grant to the State Health Society, under Revised National TB Control Programme for the year 2015-16.
