- 2. In Government letter seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to sixth read above and as per the norms of the Indian Nursing Council, New Delhi.
- 3. In his letter eighth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommended to grant permission to the Chairman, Velammal Educational Trust, Madurai to start two years M.Sc (Nursing) course with an annual intake of 12 seats in the name and style as "Velammal College of Nursing", Madurai.
- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Chairman, Velammal Educational Trust, Madurai to start two years M.Sc Nursing course with an annual intake of 12 (twelve) seats and style as Velammal College of Nursing S.F. Nos.58/7, 58/8, 58/9A, 58/9B, 58/10, 63/2, 75/12, 75/13A, 75/13B, 75/13C at Anupanadi Village, Madurai-Thirumangalam Ring Road, Madurai South Taluk, Madurai- 625 009, subject to fulfill the specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-
 - The Trust should obtain building plan approval from the Directorate of Town and Country and Planning (DTCP) for the academic and Hostel building of proposed nursing institution.
 - ii. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively before admitting the students as detailed below:-
