ORDER:

The Managing Trustee / Director, N.R.Thiagarajan Memorial Educational and Charitable Trust, Theni has requested to grant permission to start four years B.Sc Nursing Course at N.R.T. College of Nursing, Theni with an annual intake of 60 students from the academic year 2018-2019.

2. Based on the request, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Nursing College, has fulfilled the conditions prescribed by the Government and Indian Nursing Council, New Delhi. The Director of Medical Education has submitted the proposal with the Inspection report / Project Report along with his specific recommendation and requested to issue necessary orders.

3. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. Accordingly, the Government accept the recommendation of the inspection committee and the remarks of the Director of Medical Education and grant permission to the Managing Trustee / Director, N.R.Thiagarajan Memorial Educational and Charitable Trust, Theni to start 4 years B.Sc Nursing course at N.R.T. College of Nursing, in S.F.No.254/2,3 A, 255 /1 (PT), 2 and 1378 /7A (PT) # 380, Madurai Main Road, Theni with an annual intake of 60 students from the academic year 2018-2019, subject to the following conditions:-

- a) Admission of students should be made as per the rules fixed by the Government from time to time.
- b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that NO CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Nursing Colleges.

- c) The Trust should obtain suitability / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, and Tamil Nadu Dr. M.G.R. Medical University and recognition of Indian Nursing Council, New Delhi, if needed, respectively before admitting the students.
- d) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons etc.
- e) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- f) The Trust should not run any other Nursing institution within 10 kms radius.
- g) The Trust should fulfill the Teacher Student ratio as per the norms of Indian Nursing Council, New Delhi.
- h) The Trust should obtain the building completion certificate from the competent authority and the building plan approval from the Directorate of Town and Country Planning (DTCP) for the proposed Nursing College and submit to the Government before admitting the students.

4. The Director of Medical Education is directed to take necessary further action accordingly.
