ORDER:

In the letter second read above, the Director of Public Health and Preventive Medicine has stated that the Office of the Deputy Director of Health Services, Thiruvannamalai is functioning in a private rented building from 01.03.2010 and he has requested the Government to issue sanction orders for payment of rent at Rs.24,680/- per month to the Deputy Director of Health Services, Thiruvannamalai for the period from 01.03.2010 to 28.02.2011 and 01.03.2011 to 29.02.2012.

2. As per the orders issued in G.O.(Ms).No. 753, Public Works Department, dated 07.04.1984, the rent of the Private Buildings, where Government offices are functioning, can be enhanced once in three years.

3. The Government have carefully examined the above said proposal of the Director of Public Health and Preventive Medicine. Accordingly, sanction is accorded for a sum of Rs.8,88,480/- (Rupees Eight Lakhs Eighty Eight Thousand Four Hundred and Eighty only) (@ Rs.24,680 x 36 months) towards the expenditure in connection with the payment of rent to the Office of the Deputy Director of Health Services, Thiruvannamalai, for the period from 01.03.2010 to 28.02.2013.
